Sir,

I, Smt. Bandana Rajwar, Wife of Duryodhan Rajwar, a resident of Village & P.O. Chakra, P.S. Purulia(M), District Purulia would like to lodge this F.I.R. against 1) Laltu Rajwar S/o Late Chutununu Rajwar 2) & Smt. Purnima Rajwar Wife of Laltu Rajwar, both are residents of Village & P.O. Chakra, P.S. Purulia(M) District-Purulia on the following facts:-

1. That yesterday i.e. on 21/03/2023 at about 7.00 P.M. when I along with my husband Duryodhan Rajwar, were coming to our house after distributing some clothes like Sarees and other materials, so at the time of returning back to our house at that time the aforesaid Laltu Rajwar and Purnima Rajwar come suddenly and began to hit me and my husband with Iron Rod and spade. Purnima Rajwar hit us with the iron rod & Laltu Rajwar hit us with spade, in my head. The aforesaid persons also hit my husband's head with Spade & Iron Rod. I sustained bleeding injury in my head and immediately Blood began to flow upon from my head and I became unconscious. After while I regain consciousness and after that my husband and my brother, uncle, father took me and my husband ~~and~~ in my Hospital, and admitted me in Hospital at about 11 P.M. I received 3 stitches in my head and the X-Ray <sup>of</sup> ~~and~~ my head has been done. My husband was also treated by the Doctors but he did not receive so serious injury.

I was growing in pain and the aforesaid culprits without any reason began to hit me. Be it mentioned here that the Discharge Certificate from the Hospital is attached herewith.

I, therefore request you, Sir, to initiate a Criminal case against the aforesaid Laltu Rajwar and his ~~wife~~ Wife Purnima Rajwar as they hit me and my husband with Iron Rod and spade and take strict ~~action~~ action against them so they can be legally punished for their offensive behaviour. I and my family members can lead a peaceful life.

I being a woman received such growing with Pain in my humble request to take action against ~~me~~ the aforesaid culprits by starting a criminal case and they can be arrested thereafter.
