Sub: Complaint against one Renghu Rajwar (33 Yrs) S/o- Lt. Lafar Rajwar of Vill- Mahuda, PS- Purulia (M), Dist- Purulia to start a specific case.

Sir,

In producing herewith one arrested accused person Renghu Rajwar (33 Yrs) S/o- Lt. Lafar Rajwar of Vill- Mahuda, PS- Purulia (M), Dist- Purulia along with seizure list and seized articles.

I beg to submit that today (25.03.2023) while I was detailed to perform Raid duty in the PS area along with C/- 154 Rajib Nag & C/- 982 Syamal Kr. Rajwar both of Purulia (M) PS & Purulia (M) PS GDE No- 1312 Dtd. 25.03.2023. During my mobile duty, I received a secret tip off that an illegal possession of a huge amount of country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that is a shop of the arrested accused at Mahuda village and after arriving at the spot and as per instruction conducted a raid in that area under this PS at 15.25 hrs. During the raid some persons fled away in the shop of Renghu Rajwar and detained one person. On being asked he disclosed his identity as Renghu Rajwar (33 Yrs) S/o- Lt. Lafar Rajwar of Vill- Mahuda, PS- Purulia (M), Dist- Purulia. On interrogation he confessed that he stocked the country spirit for selling illegally in his shop so that he could gain more amounts from the selling of (liquor) country spirit. On demand he failed to produce any valid document in respect of keeping and selling said (liquor) country spirit at his shop. Subsequently, I seized 18 (Eighteen) sealed plastic bottle country spirits containing 600 ml. each and labeled with "DIL KHUSH" under proper seizure list in presence of witnesses and also duly signed by the accused person. The seizure was done in between 15.45 hrs and 16.05 hrs


Hence, I arrested the above noted accused person after informing him the grounds of arrest and issued Memo of Arrest and after observing all legal formalities in respect of the Arrest also informed his relatives. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them as well as the accused person. The arrest was made at 16.10 hrs.


