Sub: Complaint against one Marich Bauri (66 Yrs) S/o- Lt. Barun Bauri of Vill- Raghabpur, PS-Purulia (M), Dist- Purulia to start a specific case.

Sir,

In producing herewith one arrested accused person Marich Bauri (66 Yrs) S/o- Lt. Barun Bauri of Vill- Raghabpur, PS- Purulia (M), Dist- Purulia along with seizure list and seized articles.

I beg to submit that today (27.03.2023) while I was detailed to perform mobile duty in the PS area along with C/- 1350 Subodh Bauri & C/- 2505 Anup Kundu both of Purulia (M) PS & Purulia (M) PS GDE No- 1416 Dtd. 27.03.2023. During my mobile duty, I received a secret tip off that an illegal possession of a huge amount of country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that is a shop of the arrested accused Marich Bauri at Raghabpur (Dhobapara) village and after arriving at the spot and as per information conducted a raid at 18.05 hrs in that area under this PS. During the raid some persons fled away from the shop of Marich Bauri and detained one person. On being asked he disclosed his identity as Marich Bauri (66 Yrs) S/o- Lt. Barun Bauri of Vill- Raghabpur, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he stocked the country spirit for selling illegally in his shop, so that he could gain more amounts from the selling of (liquor) country spirit. On demand he failed to produce any valid document in respect of keeping and selling of said (liquor) country spirit at his shop. Subsequently, I seized 28 (Twenty Eight) sealed plastic bottle country spirits containing 600 ml. each and labeled with "DIL KHUSH" under proper seizure list in presence of witnesses and duly signed by the accused person. The seizure was done in between 18.25 hrs and 18.40 hrs

Hence, I arrested the above noted accused person after informing him regarding the grounds of arrest and issued a Check List and after observing all legal formalities in respect of Arrest. I also informed his relatives regarding the arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them as well as the accused person. The arrest was made at 18.45 hrs.

Under the above fact and circumstance kindly take necessary lawful action against the arrested accused person namely Marich Bauri (66 Yrs) S/o- Lt. Barun Bauri of Vill- Raghabpur, PS- Purulia (M), Dist- Purulia.
