Sir,

In producing herewith one arrested accused person namely Gholtu Bauri (38 Yrs) S/o Lt. Sudhir Bauri of Telkal Para, Simulghuta, Ward No-16, PS- Purulia (T), Dist. - Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

(1) 19 (Nineteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.

(2) Out of 19 (Nineteen) bottles 01(one) bottle is kept as sample.

I, LSI Madhuri Roy, beg to report that while I was performing 1st Special mobile duty vide Purulia (T) PS GDE No- 255 dated 05.03.23, at about 12:15 hrs received a secret telephonic information from source that one person namely Gholtu Bauri (38 Yrs) S/o Lt. Sudhir Bauri of Telkal Para, Simulghuta, Ward No-16, PS- Purulia (T), Dist. - Purulia is selling country spirit illegally at a higher price causing unlawful gain to his by unlawful loss to the purchasers from his dwelling house at Simulghuta.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of NVF/797 Badal Singh Mura and NVF/188 Arup Mahato all of Purulia (T) PS proceeded to work out the information.

At 12:35 hrs we reached at Simulghuta and keeping our Govt. vehicle at a reasonable distance we preceded towards Simulghuta as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them fled away leaving some plastic glasses at the spot. On hot chase seller could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of the shop we found 19 (Nineteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such at about 12:55 hrs to 13:25 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrested him at 13:45 hrs observing all the formalities as the sald person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
