Subject: - FIR against Ashok Kumar Chatterjee, Son of Bhupendranath Chatterjee, resident of Garikhana bye lane near Roy decorators, Purulia(T) thana, Dist Purulia.

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1/a of the electricity Act 2003, Amendment of 2007 as stated here under.

On 16/03/2023 at 11.05 Hrs. I, Sri Subhajit Pratihar, A.E & Station Manager, Purulia Customer Care Centre (CCC) along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL), Chinmay Maity (JE Purulia CCC), Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL), Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for domestic purpose at the domestic premises of Ashok Kumar Chatterjee, Son of Bhupendranath Chatterjee, resident of Garikhana bye lane near Roy decorators, Purulia(T) PS, Dist Purulia.

During the time of inspection at the premises 2 nos service connections were found having meter serial no G01794028 and IPBB273878.

It was observed that accused Ashok Kumar Chatterjee has made unauthorized use of electricity under section 135 1/a by direct tapping from the incoming service cable before the meter through a 2X1 core pvc cable of length 4 feet approx, connected to a switch board. From the above arrangement the accused was using 1 nos Pump of 1 HP.(746 watt)

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service connections from pole with the help of LT Mobile Van Team and removed & seized the 2X1 core pvc cable of length 4 feet approx along with the hooking arrangement.

The inspection team left the premises at about 11:35 Hrs on 16th March 2023.

The accused committed theft of electricity U/S 135 1/a of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
