Subject: - FIR against Md Atahar Jawed Khan , Son of Sultan Khan, resident of Ranibandh Rajbasti ,Purulia(T) thana , Dist Purulia .

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1/b & 1/c of the electricity Act 2003, Amendment of 2007 as stated here under.

On 16/03/2023 at 12.50 Hrs. I, Sri Subhajit Pratihar , A.E & Station Manager , Purulia Customer Care Centre (CCC) along with Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL), Chinmay Maity (JE Purulia CCC) , Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL), Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for domestic purpose at the domestic premises of Md Atahar Jawed Khan , Son of Sultan Khan, resident of Ranibandh Rajbasti ,Purulia(T) PS, Dist Purulia by serving one entry notice duly signed by the consumer representative.

During the time of inspection at the premises 1 nos of electricity meter were found having serial no BB1122228 (Consumer id 203166795, Consumer Name- Atahar Jawed Khan) .

It was observed that user Md Atahar Jawed Khan has made unauthorized use of electricity under section 135 1/b & 1/e by inserting foreign material in meter serial no BB1122228, which works as resistance to interfere with accurate or proper registration of electricity consumption & also made unauthorized use of electricity under section 135 1/c & 1/e by damaging or destroying an electric meter having serial no BB1122228 and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 2 nos (60 watt each) , Light 120 nos (3x40 watt each) , Pump 1 nos 375 watt Heater 1000 watt , washing machine 500 watt , Fridge 200 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected the service lines from pole with the help of LT Mobile Van Team and removed & seized 1 nos of energy meter having serial no BB1122228. Prepared inspection sheet and seizure list duly signed by the accused.

The inspection team left the premises at about 13:25 Hrs on 16th March 2023.

The accused committed theft of electricity U/S 135 1/b, 1/c of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
