Rupchand Kumar of Village- Belyadih, PS- Kotshila, Dist- Purulia, who was serving sentence at Purulia District Correctional Home in connection with Kotshila PS Case No. 23/09, Dated 28.06.09, SC- 129/2009, U/S- 302/34 IPC was released on parole for 20 (Twenty) days w.e.f. 24.02.2023 to 17.03.2023 before evening lockup as per order of the AIG (HQ) of Correctional Services, West Bengal vide memo no. 237/DCS-16011(15)/24/2023-SECTION(DCS)-DCS, Dated 22.02.2023. but the said life convict didn't return back from parole to this Correctional Home on 17.03.2023.
