In producing herewith the following seized articles –

- (i) **Exhibit Mark A-** One white colour plastic Jar with Red cap containing Codeine Mixture total weight 2050 gram out of which 03 sample collected each bottle contains 100 gram Codeine Mixture then weight of Mother Sample weighing 1750 gram - Exhibit Mark A (mother Sample).
- (ii) **Exhibit Mark A1-** 100 gm Codeine Mixture as test sample, leveled and sealed condition, taken from Exhibit Mark A.
- (iii) **Exhibit Mark A2-** 100 gm Codeine Mixture as test sample, leveled and sealed condition, taken from Exhibit Mark A.
- (iii) **Exhibit Mark A3-** 100 gm Codeine Mixture, as security sample, leveled and sealed condition taken from Exhibit Mark A.

I, SI Tufan Kr. Dawn of Purulia Town PS beg to state that on 13.03.2023 received a written complaint of Samir Kumar S/O- Kalu Kumar of Nadiha, Bibir Bandh Para, PS- Purulia (T), Dist- Purulia to the effect that on 13.03.2023 at 10:00 hrs near Kasai Mohalla Masjid Choumatha More when he collected empty carets of Amul Milk on vehicle vide Reg. No- WB55B/5890 at that time one unknown person push him and snatch a bag in which total collection of Rs. 86,184/- were kept for the day. Later the complainant came to know from local people that the name of said offender person is Sk. Azad S/O- Sk. Jumman of Digudih Para, PS- Purulia (T), Dist- Purulia. Over the complaint of the complainant started Purulia (T) PS Case No- 47/2023 dated 13.03.2023 U/S 392 IPC. Accused Sk. Azad dully forwarded before the Ld. Court on 14.03.2023 under proper escort with all relevant papers and taken 07 days Police remand of accused Sk. Azad. During interrogation of his PC period he confessed that he will help Police authority to recover the robbed money in his house, accused Sk. Azad also stated that he decided that he will give up this type of snatching theft profession as it is very risky when he apprehended by public and man handle by them. So he decided to start a new business of Cough Syrup recently. But this business is very costly to procure raw materials. Due to necessity of liquid cash he committed the robbery on 13.03.2023 at Digudih Para. He also stated at the same time the robbed money and the Cough Syrup jar (codeine mixture) concealed in his own house in a secret place covered by cloths. He will help the police to recover the robbed money and Codeine Mixture jar which are kept in his own house. The matter was diarized vide Purulia Town PS GDE No- 1648 Date- 18.03.2023. Accordingly I SI Tufan Kr. Dawn informed IC Purulia Town regarding this matter.

On 18.03.2023 i.e. today at 21:45 hrs we accompanied with IC Purulia Town PS, Shri Manas Kr. Sarkar, Inspector of Police and SI Gopal Ch. Man, ASI Ujjal Rajak, ASI Dharam Das Rajak, C/2366 Anupam Das, C/2345 Debshankar Barik, C/2653 Nirmal Mahata left for Digudi Para with accused Sk. Azad vide GDE No- 1653 Date. 18.03.2023 and vide C.C. No 804 Date. 18.03.2023 by Govt. vehicle bearing no WB 56C 5421. With a view to conduct such as per leading statement of PC accused Sk. Azad. After collecting necessary articles like white paper, Carbon papers, brown paper, Stamp pad, Weight Machine, Sealing wax, Candle brass seal, match Box, needle & thread, investigation box, Drug detection kit etc. I would like to note here that I/C Purulia (T) PS tried to make contact with SDO Sadar Purulia for deputing an Executive Magistrate but none was available at the odd hours of night. IC Purulia Town PS also called a phone from his official number from PS and place of search but due to non availability and odd hours of night no one came forward.

On 18.03.2023 at 22:25 hrs after arrival at Digudi Para under Purulia Town PS we tried to get two disinterested witnesses namely (1) Balaram Nandi @ Bhola S/O Lt. Gobardhan Nandi Of Namopara, Ward No- 19, PS-Purulia (T) PS, Dist- Purulia (2) Rajen Banerjee @ Kalpa S/O Bimal Banerjee of Dolgobinda Chatterjee Lane, Rathtola, Ward No- 12, PS- Purulia (T) PS, Dist- Purulia.

I/C Purulia Town PS being as Gazetted Officer issued a notice to the PC accused Sk. Azad mentioning that whether he was willing to search the body of gazette officers alongwith other accompanying officers and force. The content of the notice was read over to the PC accused and he searched Police Personnel but found nothing except official belongings and accordingly I prepared new seizure list in presence of witnesses.

Then I issued Notice in writing upon the said person directing him whether he was willing to be searched his person (body) before any Gazetted officer. The content of the notice was read over to the accused person. He gave consent.


In presence and under your kind supervision, PC accused Sk. Azad brought out one Jar and bag in which cash Rs 66,410/- and two Aadhaar Card No. 445628088496 in the name of Sk. Sahajada S/O Sk. Ramjan of Taldanga, Ward. No. 08 Purulia Municipality, Purulia-I, Purulia and Aadhar No. 838611668682 in the name of Samir Kumar and on the said bag one logo of "Fastrack" found which were kept in a hidden place, from his room at his dwelling house. The above noted cash Rs 66,410/- and other materials of seized bag in c/w Purulia Town PS Case No Purulia (T) PS Case No- 47/2023 dated 13.03.2023 U/S 392 IPC in separate seizure list by me as I.O of the case. After opening the plastic Jar containing liquid which seems as contraband like substance (Codeine Mixture). During opening the cap of the plastic Jar and aromatic smell was found. On demand, PC accused Sk. Azad failed to produce any kind of documents in respect of storing of Codeine Mixture. During interrogation PC accused stated that he is just starting this illegal business of Codeine mixture for commercial purpose by such clandestine manner. This illegal commercial purpose for his wrongful gain knowing the same is a punishable offence. Then I weighted the Jar and its result 2050 gram in electronic weight machine. On reasonable belief and offence has been committed in respect of recovered liquid substance believe to the Codeine Mixture from which 300 gm was taken as test sample in three bottles of 100 gm each.

In between 23:15 hrs to 23:55 hrs (18.03.2023), I prepared seizure list in respect of Exhibit Mark-A, A1, A2, A3 containing 2050 gm Codeine Mixture, 100 gm taken from mother sample as test sample A-1, 100 gm taken from mother sample as test sample A-2, 100 gm Codeine Mixture taken from mother sample A-3 for security sample and at the same time I label the same in presence of you and other two disinterested witnesses, two inmates as well as accused person duly signed by each of them. I served a copy of seizure list to the PC accused person namely Sk. Azad. The entire search and seizure process was properly videographed.

The PC accused Sk. Azad is liable for prosecution U/S 21(c)/29 NDPS Act. 1985. as amended up to date.

Under this circumstances, I request you to initiate a case against Sk. Azad (27 yrs) S/O- Sk. Jumman of Digudih Para, PS- Purulia (T), Dist- Purulia U/S 21(c)/29 NDPS Act. 1985 as amended up to date and arrange for its investigation.
