Sir,

I Shri Sekhar Kr. Mitra, Inspector of Police, DEB, Purulia do here by lodge type complaint being produced the accd person namely (1) Dip Roy (30 yrs.) s/o Lt. Mohan Roy of Bhuinya Para, Ward No.07, PS Purulia(T), Dist Purulia (2) Raju Majhi (29 yrs.) s/o Sambhu Nath Majhi of Dulmi-Nadiha Netaji Subash Road by lane (Chatanipara) near Netaji School, Ward No. 06, PS. Purulia (T), Dist. Purulia along with the following seized articles (1) 03 (three) pcs. Domestic LPG cylinders of HP company-fully loaded with LPG (2) 02 (two) pcs. empty domestic LPG cylinders of HP company (3) 01 (one) pc. empty commercial LPG cylinder of HP company (4) 01 (one) pc. empty commercial LPG cylinder of INDANE company (5) 01 (one) pc. small 05kg LPG cylinder of HP company fully loaded with LPG (6) 05 (five) pcs. empty small 05kg LPG cylinders of local made (7) 01 (one) pc. Nozzle apparatus having length approx 9 inches made by Iron Metal (8) 01 (one) pc. Nozzle apparatus having length approx 2 1/2 inches made by Copper Metal both Nozzle used for re-filling gas from one to another cylinders (9) 01 (one) pc. Nozzle apparatus fitted with double rubber pipe one side of nozzle (having length of nozzle approx 4 inches and rubber pipe having length approx 2 1/2 feet each) used for re-filling gas from one to another cylinders (10) 01 (one) pc. small back colour electronic weighing machine having length approx 3 inches used for measuring LPG Gas and Cylinder to the effect that today on 22.03.2023 on the basis of secret and credible information I, along with ASI Swapan Chakraborty, W/C 88 Pradyut Mandal, HG/1427 Benimadhab Char had been to Purulia(T) PS and submitted one requisition to OC Purulia(T) PS for rendering assistance in respect of credible information at 11:15hrs. has been noted vide Purulia(T) PS GDE No. 1861 dtd.22.03.2023 at 11:35 hrs. Thereafter we along with officer and force of Purulia(T) PS left for Amdiha Road under Purulia(T) PS to work out the information. On arrival near Amdiha Road at about 13:15hrs to work out the information, I asked two local people viz. (1) Paresh Roy s/o Lt. Moti Roy of Amdiha near Hari Mandir (2) Avisekh Das s/o Srikanta Das of Amdiha near Hari Mandir both of PS Purulia(T), Dist. Purulia to assist us for holding raid, search and seizure in the shop of one Dip Roy s/o Lt. Mohan Roy of Bhuinya Para, Ward No.7, PS Purulia(T), Dist Purulia his shop is situated by the side of Amdiha Road, Ward No. 6, PS. Purulia (T), Dist. Purulia. Prior to holding raid in the shop, we noticed some Domestic / Commercial LPG cylinder kept inside the shop along with apparatus which is used for refilling LPG from one to another cylinder. The owner namely Dip Roy along with Raju Majhi runs the shop. They were asked to produce valid documents / license for running their business in respect of possessing such Domestic / Commercial LPG cylinders

and also such business of refilling, but the owner and his associate one failed to produce any valid documents / license for running such illegal business. Thereafter myself along with accompanied officers and force along with the active assistance of above noted two local witnesses as noted above held raid in the shop of Dip Roy s/o Lt. Mohan Roy of Bhuinya Para, Ward No.07, PS Purulia(T), Dist Purulia, after observing all formalities relating to search and seizure. As such I seized the above noted articles with proper labeling in presence of local witnesses and police witnesses under proper seizure list from the shop of Dip Roy in between 13:45 hrs to 14:35 hrs.

Dip Roy & Raju Majhi both failed to produce any valid documents / papers for running such illegal business. Hence he violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Thus both the accused person namely Dip Roy & Raju Majhi has committed an offence punishable u/s 7(1)(a)(ii) of E.C.Act'1955. It appeared that if they are not arrested now they may tamper with evidences and they are also very likely to hinder investigation. So the said Dip Roy & Raju Majhi were arrested after informing them the ground of arrest and issued Memo of Arrest to both of them in presence of their relative duly signed by them at 14:45 hrs. & 14:55hrs.

In course of local enquiry it revealed that said Dip Roy and his associate are running clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license and only for causing their wrongful gain and causing loss of revenue to the Govt.

I therefore request you to start a case u/s 7(1)(a)(ii) of E.C.Act'1955 against both the accused (1) Dip Roy (30 yrs.) s/o Lt. Mohan Roy of Bhuinya Para , Ward No.07, PS Purulia(T), Dist Purulia (2) Raju Majhi (29 yrs.) s/o Sambhu Nath Majhi of Dulmi-Nadiha Netaji Subash Road by lane (Chatanipara) near Netaji School, Ward No. 06, PS. Purulia (T), Dist. Purulia.

As per order of S.P(DEB), Purulia SI Amaresh Das of DEB, Purulia will investigate the case.
