Respected Sir,

In producing herewith the seized vehicle (Tractor) having Reg. No. JH09N-9507 attached with Trolley having no- JH09N-9508 loaded with sand approx 100 cft. with proper Seizure list.

The fact brief is that today (24.03.2023) at 18:05 hrs while I along with force 1) C/241-Sumit Chakraborty, C/2505-Anup Kundu both of Purulia (M) PS left the PS for Spl. mobile duty vide Purulia (M) PS CC No 951/23 and GDE No 1282 Dt. 24.03.2023 at Ranchi road area. During my spl mobile duty, I received a tip off at 18:20 hrs that a suspicious tractor loaded with sand was coming from Kansai river at Kantabera Ghat. Accordingly I contacted with I/C Purulia (M) PS and as per his direction, I along with force proceeded towards Katabera Ghat to work out the tip off. While I along with force arrived at Ghagarjuri Kafarbon and found 01 (one) tractor loaded attached with trolley loaded with sand at Katabera Ghat of Kansai river. I along with force intercepted the vehicle (Tractor) having bearing attached with Trolley loaded with Sand approx 100 Cft without driver or owner at 18.35 hrs and I found the vehicle as well as goods as identical as I received prior information. I moved through the surrounding area to trace out said driver or owner of said detained tractor but nobody was found to stand it ownership. The owner of the said vehicle as well as driver loaded said sand by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that driver in cahoots with the owner of the vehicle and others procured the said sand from Kansai River near Katabera Ghat under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) having Reg. No. JH09N-9507 attached with Trolley having no- JH09N-9508 loaded with Sand 100 Cft. (approx) under proper seizure list inbetween 18.45 hrs and 19.05 hrs in presence of available witnesses duly signed by them. Thereafter, I brought the said seized tractor to Purulia (M) PS compound at 19.35 hrs

Under the above facts and circumstances kindly take lawful action against the owner and the driver of the vehicle as they committed offence u/s 379/411/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
