In producing herewith the arrested accused persons namely (1) Manik Chandra Gorai (48) Sir, S/o Kadan Gorai of Vill.- Sadhu Saltora, PS - Santuri, Dist.- Purulia, (2) Pradip Chakraborty (49) S/o Dhirendranath Chakraborty of Do, (3) Ajoy Chakraborty (24) S/o Santiram Chakraborty of Do and (4) Krittibas Singh (36) S/o Ajit Singh of Vill.- Bhagabandh, PS - Santuri, Dist.- Purulia and seized 07 (Seven) Nos. two wheelers loaded with total 9 Ontls. coal. Fact of the case in brief is that on 06,03.2023 myself along with C/194 Bijoy Kr Das and NVF/1087 Sankar Gorai both of Raghunathpur PS were performing special raid duty in Raghunathpur PS area vide Raghunathpur PS CC No. 638/23. On 07,03.2023 at about 04:35 hrs. received a credible source information that some persons were assembled for loading coal in a two wheelers with a view to illegal transporting, from Sankra village surrounding area under Raghunathour PS. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at KMC Auto Mobile at Ifradanga. Then we have cordoned the place by our police personnel and found that some persons having loaded coal were coming, at that time we were able to apprehend 07 (Seven) Nos. of two wheelers vide (1) One TVS XL 100 motor cycle bearing Reg. No. WB 82A/7094 loaded with approx 1.5 Qntl. Coal in plastic bag, (2) One TVS XL Super (Heavy Duty) motorcycle hearing Reg. No. 56E/5137 loaded with 1.5 Qntls. (Approx) coal in plastic hag, (3) One Discover motorcycle bearing Reg. No. WB 82A/5445 loaded with 1.5 Qntls. (Approx) coal in plastic bag, (4) One TVS XL Super (Heavy Duty) bearing Reg. No. JH 10AA/0985 loaded with 1.5 Ontls. (Approx) coal in plastic bag, (5) One LML Vespa having No Registration Number loaded with 01 Qntl. (Approx) coal in plastic bag, (6) One LML Vespa having No Registration Number loaded with 01 Qntl. (Approx) coal in plastic bag and (7) One Piaggo Scooter having No Registration Number loaded with 01 Qntl. (Approx) coal in plastic bag and 04 (three) riders as noted above and 03 (three) riders have been fled away. On asking the riders of the said two wheelers failed to produce any papers in respect of said loaded Coal as well as papers in respect of those two wheelers. They also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those two wheelers collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation they confessed their guilt. As such it is every reason to believe that those persons along with two wheelers are transporting the said coal illegally. As such I seized those two wheelers loaded with Coal under proper seizure list duly signed by the accused persons and witnesses. I also arrested of those persons after observing all formalities and narrating their ground of arrest. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each two wheelers collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Manik Chandra Gorai (48) S/o Kadan Gorai of Vill.- Sadhu Saltora, PS – Santuri, Dist.- Purulia, (2) Pradip Chakraborty (49) S/o Dhirendranath Chakraborty of Do, (3) Ajoy Chakraborty (24) S/o Santiram Chakraborty of Do and (4) Krittibas Singh (36) S/o Ajit Singh of Vill.- Bhagabandh, PS – Santuri, Dist.- Purulia and 03 others as per law and arrange for its investigation.
