Sir,

In producing herewith seized article 160 MTs (Approx) Steam Coal along with seizure list dated- 10.03.2023. I beg to report that on 10.03.2023 myself along with ASI Sk Monsur, C/1267 Nabin Patra, C/194 Bijay Das all of Raghunathpur PS were performing special raid duty in Raghunathpur PS area vide Raghunathpur PS CC No. 444/23. At about 08:25 hrs. received a credible source information that huge quantity of coal were stocked at inside bush area near Shyambandh of Sagarhira, Kalikend Para under Kargali village, PS – Raghunathpur, Dist.- Purulia with a view to illegal transporting the same in lieu of money. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at the same place, parked the vehicle from a distance and started walking towards the place of occurrence. Then we have cordoned the place by our Police personnel and found that the huge quantity coal was stocked there as well as nobody was present there. From the local enquiry it could be learnt that the said illegal coal have been collected either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains. As such it is every reason to believe that some unknown persons are jointly stocking the said coal illegally. I also seized Coal in between 09:15 hrs to 10:55 hrs under proper seizure list duly signed by the witnesses. Approx 02 (Two) K.G. of Coal collected as sample coal. During local enquiry it came out that (1) Sricharan Gorai S/o Jogen Gorai of Vill.- Kargali, PS – Raghunathpur, Dist.- Purulia, (2) Swapan Modak S/o Nilkamal Modak of Vill.- Chelyama, PS – Raghunathpur, Dist.- Purulia, (3) Santosh Mandal S/o Lt. Dharam Mandal of Kargali, PS – Raghunathpur, Dist.- Purulia and others involved associates.

I therefore pray before you, kindly lodge an FIR against the accused persons namely (1) Sricharan Gorai S/o Jogen Gorai of Vill.- Kargali, PS – Raghunathpur, Dist.- Purulia, (2) Swapan Modak S/o Nilkamal Modak of Vill.- Chelyama, PS – Raghunathpur, Dist.- Purulia, (3) Santosh Mandal S/o Lt. Dharam Mandal of Kargali, PS – Raghunathpur, Dist.- Purulia and others involved associates as per law and arrange for its investigation.
