Sir,

In producing herewith the arrested accused person namely Dinabandhu Bauri (38) S/o Narad Bauri of Vill.- Ramnagar, PS – Raghunathpur, Dist.- Purulia, driver of tractor bearing MODEL Name – 434E21, Chasis No T053597668BL, Engine No E3673559 (Blue Colour Power Trac) with trolley loaded with approx 100 Cft. sand. Fact of the case in brief is that on 25.03.2022 myself along with C/45 Samir Kr Mahato, C/685 Dilip Chhatait, C/847 Uttam Hazra all are Raghunathpur PS were performing Evening Mobile Duty on Raghunathpur – Santaldih road and at about 16:05 hrs. received a source information that the above noted tractor loaded with sand was going towards Santaldih side. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we had been to Raghunathpur – Santaldih road near at Salka more and waiting for the said tractor and at about 16:15 hrs found that the above noted tractor is coming from Raghunathpur side. We stopped the said tractor and on searching it is found that the said tractor was loaded with sand and on asking driver of the said tractor failed to produce any papers in respect of loaded sand as well as papers in respect of the said tractor. He also made incoherent statement in respect of possession of the said sand in his tractor which he was driving. So, it is reasonable to believe that the driver and owner of the said tractor collected the said sand either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains. On interrogation the driver of the said tractor confessed his guilt. As such it is every reason to believe that the driver and owner of the said tractor transporting sand illegally. As such I seized the tractor having without registration number loaded with approx 100 Cft. stolen sand under proper seizure list duly signed by the accused driver. Also arrested the accused driver of above noted tractor namely Dinabandhu Bauri (38) S/o Narad Bauri of Vill.- Ramnagar, PS – Raghunathpur, Dist.- Purulia after observing all formalities and narrating him the ground of arrest. No public witness was available there. Approx 01 (One) K.G. of Sand sealed & labeled as sample Sand from major contraband.

I therefore pray before you, kindly lodge an FIR against the driver namely Dinabandhu Bauri (38) S/o Narad Bauri of Vill.- Ramnagar, PS – Raghunathpur, Dist.- Purulia and owner of the tractor bearing MODEL Name – 434E21, Chasis No T053597668BL, Engine No E3673559 (Blue Colour Power Trac) as per law and arrange for its investigation.
