Respected sir,

In producing herewith one seized vehicle (Truck loaded with sand) having Registration number WB37C/9655, Engine No.- 51F63445590 & Chassis No: MAT448117F2F09466, attached with Seizure List. The nub of the fact in a nutshell is that today (15.03.2023) while I, along with C/1457 Nityaranjan Rajwar & C/809 Madhusudan Mahato , were performing mobile duty vide Santaldih PS GDE no. 604, dated 15.03.2023, in Santaldih PS area, I, received a tip off at 13:25 hrs on 15.03.2023 that, near Deoli (HS) School under Santaldih PS, some persons were illegally carrying sand by a suspicious truck. Subsequently, I along with force proceeded toward Deoli (HS) School more to work out the tip off. While, I along with force arrived at Deoli (HS) School more under Santaldih PS and found that, some persons are illegally carrying sand into a truck.

I, along with force proceeded to detain the vehicle and reached at the spot i.e. Deoli (HS) School more, PS – Santaldih at 13:35 hrs but seeing the police persons the driver left the truck having Registration number WB37C/9655, Engine No.- 51F63445590 & Chassis No: MAT448117F2F09466, loaded with sand and fled away. I tried to find out the name & address of the driver / owner of the truck but in vain.

During enquiry, it is ascertain that the driver of the said truck loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said sand by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they are habitual offender of this crime, as they have been engaged in the said illegal business since long, behind the eyes of the administration.

So, I, seized the said blue colour tractor having registration number WB37C/9655, Engine No.- 51F63445590 & Chassis No: MAT448117F2F09466, loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter, I had been to Parbati weigh bridge , Paharigora and arranged its weighing , which is net weight 35,860 KG. Then I brought the seized truck along with the loaded sand to Santaldih PS.

Under above fact and circumstances, I, pray before you to start a specific case against the Owner & Driver of the above noted truck having Registration number WB37C/9655 Engine No.51F63445590 & Chassis No: MAT448117F2F09466, under proper sections of law.
