Respected Sir,

In producing herewith 03 (three) Buffalo cart along with approx 03 (Three) tons coal each out of these 01 (one) kg coal from each cart seized as Sample with proper seizure list. The fact of the case in brief is that today (11.03.23) at about 10.45 hrs when myself along with force were on mobile duty then received a source information that some persons near at Kabar Sthan of Murulia village engaged in transporting coal after procuring the same in illegal manner in 03 (three) Buffalo cart for clandestine business hatching a criminal conspiracy with a view to wrongful gain after forming a racket.

Accordingly, I conveyed this source information the matter to O/C Santuri PS and as per his direction I along with force proceeded for the anticipated place to work

out the information.

Subsequently, I along with accompanying force reached at that spot near Kabar Sthan at about 11.35 hrs as per the information and as described by the source. Seeing our police van from a distance three persons who were engaged in transporting coal managed to escape before we could get at them. After that we searched the place and its adjacent areas and found 03 (three) Buffalo cart loaded with approx 03 (Three) tons coal in each cart. Accordingly, I held a local enquiry to know the involved persons as well as to establish their proper identity and came to learn their names and address as 1) Sk Refakot s/o Sk Safik, 2) Sk Sahid s/o Rafik and 3) Sk Anish s/o Sk Khoyabun all of vill Murulia, PS Santuri, Dist Purulia were engaged in extracting and transporting the said coal. I seized the said 03 (three) Buffalo cart loaded with approx 03 (Three) tons coal in each cart out of these 01 (one) kg coal from each cart seized as Sample with proper seizure list duly signed by the available witnesses. It is reasonable to belief that above noted persons who managed to flee away from that spot were engaged for extracting, lifting and transporting of illegal coal for clandestine business hatching a criminal conspiracy with a view to wrongful gain after forming a racket after procuring the same by theft or any fraudulent means. So the above noted persons are liable for committing an offence punishable U/S 379/411/414/120B IPC & r/w Sec 30(2) CMN Act, 1973.

I arranged to bring the said 03 (Three) buffalo cart loaded with coal at PS and lodged this complain against the above noted accused persons for stating a Case as per
