Sir,

I, Shri Sekhar Kr. Mitra, Inspector of Police, DEB, Purulia, do here by lodge complaint being produced the accd person namely 1) Ajoy Middy^{@ Middyha} (44) S/O- Lt. Paresh Middy^{@ Middyha} of Vill- Hijuli, PO. Saltore, PS- Neturia, Dist Purulia 2) Subhash Middy^{@ Middyha} (32) s/o Lt. Haradhan Middy^{@ Middyha}, of Vill- Hijuli, PO. Saltore, PS- Neturia, Dist Purulia along with the following seized articles:

- 1) 05 (Five) Pcs. Commercial Filling LPG cylinders of HP company sealed condition but sealed Logo is INDANE company.
- 2) 02 (Two) Pcs. Commercial Filling LPG cylinders of HP company sealed condition but sealed Logo same.
- 3) 01 (One) Pc Commercial Filling LPG cylinders of INDANE company sealed condition but sealed Logo is HP company.
- 4) 01 (One) Pc domestic Filling LPG cylinders of HP company sealed condition but sealed Logo is same.
- 5) 13 (Thirteen) Pcs empty commercial LPG cylinder of INDANE company.
- 6) 08 (Eight) Pcs empty commercial LPG cylinder of BHARAT GAS company.
- 7) 11 (Eleven) Pcs empty commercial LPG cylinder of HP company.
- 8) 02 (Two) Pcs. empty domestic LPG cylinder of HP company.
- 9) 02 (Two) Pcs. Nozzle apparatus made by Copper like metal, length approx - 2 ½ inches.
- 10) 01 (One) Pc Nozzle apparatus made by Iron like metal, length approx - 09 inches.
- 11) 01 (One) PC Rubber Gas pipe, length approx - 1.5 miters.
- 12) 01 (One) Vehicle (TATA- AC) bearing registration no. WB37B/3896.

to the effect that today on 11.03.2023 on the basis of secret and credible information I, along with ASI Swapan Chakraborty, W/C 88 Pradyut Mandal, HG/1427 Benimadhab Char had been to Tamna PS at 12:45hrs. and submitted one requisition to OC Tamna PS for rendering assistance over the credible information. At 12:55 hrs. the matter has been noted in GD vide Tamna PS GDE No- 452, dtd- 11.03.2023. Thereafter we along with ASI Jagannath Rakshit & force of Tamna PS left for Maguria, Bhatbandha - Arsha Road under Tamna PS to work out the information. On arrival at Maguria, Bhatbandha - Arsha Road at about 13:15 hrs to work out the information and found one vehicle bearing no. WB37B/3896 (TATA- AC) was standing there by the road side loaded with huge numbers of LPG cylinder (Commercial & Domestic). And also driver of the vehicle and his one associates processing converting LPG from domestic cylinder to commercial cylinder by the use of nozzle apparatus. On seeing Police they were tried to flew away after starting vehicle but we managed to stop there. On being asked they reveled their identity as noted above but their identities could not be verified as they could not produce relevant documents in respect of their address and age. On demand they failed to produce any valid papers / documents in respect of those loaded LPG cylinder and also vehicle. On being asked they did not give satisfactory reason for loading and transporting LPG cylinder in their vehicle. They also

did not give satisfactory answer for converting LPG from domestic cylinder to commercial cylinder by using device. They have stated incoherently and from their statements there is every reason to believe that they have carrying those LPG cylinder without papers for selling different places in this district illegally and their personal wrongful gain.

Hence, I seized the above noted vehicles loaded with above mention LPG cylinder from the possessions of the above noted accused persons under proper seizure list and after seizure I arrested them. They violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Hence they committed an offence punishable u/s 7(1)(a)(ii) of E.C.Act'1955. Thereafter seized articles made proper labeling in presence of local witnesses and police witnesses and prepared Arrest Memo after observing all formalities.

In course of local enquiry it revealed that both the accused persons are transporting of LPG Gas Cylinder and also selling LPG after refilling from domestic cylinder to commercial cylinder since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to the Govt.

Seized articles from Sl. No. 1 to 8 as mention above left in zimma to Pradip Kr. Mahato s/o Khedan Ch. Mahato, Vill. Durku, PS. Tamna, Dist. Purulia, Manager of Zico HP distributor of LPG vide code no. 14387800.

Seized articles from Sl. No. 9 to 12 as mention above kept in zimma to Malkhana dealing officer of Tamna PS.




As per kind order of SP (DEB), Purulia ASI Prabir Kr. Mukherjee of DEB, Purulia will investigate the case.
