Sir,

I, Md. Faisal Hussain, son of Md. Lal, a resident of J.K College Road, Querashi Mohalla, Purulia, P.O+P.S- Purulia(T), District- Purulia, would like to lodge this F.I.R against one Tasam Hawari, son of Babla Hawari, a resident of Doctor Danga, Purulia, P.O+P.S- Purulia(T), District- Purulia, on the following facts:

- 1. That I have got a piece of Land bearing R.S/L.R Plot no. 629 situated at Mouza- Belguma within P.S- Tamna and the Plot measures an area of 12 decimals.
- 2. That I have been in occupation of the Plot by constructing a Room therein and I and my family members used to reside therein sometimes.
- 3. That previously the aforesaid Tasam Hawari and others have threatened me and my family members that they will kill us and also threatened us that they will dispossess me and my family members from our lawful possession in Plot no. 629 and for which I was compelled to lodge a Diary being G.D.E No. 60/23 dated 02/03/2023 against the aforesaid Tasam Hawari and others. After that incident I installed few C.C T.V Cameras in four corners of my Room and I installed 4 C.C T.V Cameras.
- 4. That yesterday i.e. on 25/03/2023 at 03.36 PM the aforesaid culprit Tasam Hawari criminally trespassed into my Land and climbed up straight in the Roof (Asbestos) of my Room and began to break my Cameras and also broken down a portion of my Roof by making a hole in the Asbestos in one corner and after making the hole in the Roof he jumped down inside the Room and broken the Articles of my Room through the help of a Stick and thereafter fled away from the spot. This entire incident has been captured in the remaining Cameras.
- 5. That yesterday at about 06.30 PM when I visited my Room then I found that the Cameras have been broken down and the Room Articles have been damaged and broken. The whole footage of the incident has been recorded in my Cameras.

6. That I have the got the footage to show that the aforesaid Tasam Hawari have been committing the heinous act. I sustained a loss of Rs. 50000.00 for damaging my Property.

I, therefore request you to initiate a Criminal Case against the aforesaid Tasam Hawari and take all such legal actions against the aforesaid Tasam Hawari by treating this Application as a F.I.R so that he can be arrested and can be punished under Law for his heinous act and offensive nature, so that I can retained my Property.
