Sub: To lodge FIR against owner and driver of White colored Dumper having Reg. No-WB53A/8361 loaded with sand approx 400-450 Cft.

Sir,

In producing herewith, one White colored Dumper having Reg. No-WB53A/8361 loaded with sand approx 400-450 Cft before you.

The nub of the fact in a nutshell is that today on 02.04.2023 at 16.35 hrs. I SI Madan Chandra Supakar of Adra PS along with (i) C/140 Subrata Banerjee and (ii) C/1119 Susanta Kr. Sinha both of Adra PS, Dist -Purulia, left the PS for performing evening mobile duty at Adra P.S area vide Adra P.S GDE No 54 Dtd -02.04.2023 and C.C No. 1018/23 Dtd. 02.04.2023. During my mobile duty, I received a tip off at 20:15 hrs that a suspicious Dumper loaded with sand was coming from Adra Bus Stand side towards Mama More Adra. Subsequently, I along with force proceeded towards Mama More to work out the tip off. While I along with force arrived at Mama More. After that I found that one Dumper was coming from Adra Bus Stand side. I along with force moved to the spot. We kept the vehicle and proceeded towards the spot by foot. The driver of the said Dumper seeing the Police party, he left the Dumper loaded with sand and fled away from the spot. We rushed to the Dumper and detained the said Dumper. We searched the said Dumper and found that the Dumper is loaded with sand and also searched surrounding but could not find any kind of documents related to the vehicle loaded with sand. I asked local people who gathered at that place to become witnesses but none came forwarded and all of them left the place. Hence, I seized the above noted Dumper loaded with sand approx 400-450 Cft, and arranged to bring the said seized Dumper to Adra PS. As there is every reason to believe that the driver and owner of the said Dumper with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted Dumper for investigation.
