Sir,

In producing here with one arrested accused namely Dalu Banerjee (53 Yrs) S/O Lt. Ramdas Banerjee of Vill+PO-Bagda, PS-Puncha, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- (1) 60 (Sixty) bottles DIL KHUSH country spirit, 600 Ml. of each bottles Rs-55/- of each bottle
- (2) 12 (Twelve) bottles KINGFISHER bear of 650 Ml. each Rs-125/- of each bottle

I SI Mekdam Sabab of Adra PS do here by lodged a complaint to the effect that today i.e. 04/04/2023 in course of day mobile duty as per order vide Adra PS CC No-1033/23 dtd.04.04.23. I received information from a reliable source at about 12:45 hrs that selling of country spirit and foreign liquor going on illegally in a Shop at Sabji Market North Side Adra. After getting such information I informed to I/C Adra P.S. over telephone and as per his direction I along with accompanied force reached at Sabji Market and on the basis of source information I along with force held raid in a shop at the said place at about 13:15 hrs and found that one person was selling country spirit and foreign liquor. After seeing the Police party, all the customers fled away immediately. The seller also tried to conceal himself but we able to apprehend him. He disclosed his identity as Dalu Banerjee (53 Yrs) S/O Lt. Ramdas Banerjee of Vill+PO-Bagda, PS-Puncha, Dist-Purulia. I asked him to produce valid License or valid papers in respect of selling of country spirit and foreign liquor but he failed to produce any valid license or documents in respect possessing /selling the same. He also stated that the owner of the said shop is Bittu Singh @ Surjit Singh S/O Gurbachan Singh of Vill-lower Beniasol, SBI Para, PS-Adra, Dist-Purulia, who was not present at that time and he told Dalu Banerjee to look after his illegal business for the mean time. So it is sufficient reason to believe that above said Dalu Banerjee and Bittu Singh @ Surjit Singh engaged to sale the country spirit and foreign liquor by illegal way. So I seized the above mentioned country spirit and foreign liquor under proper seizure list duly sign by accused person and available witnesses. I also collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person informing him the ground of arrest. The complete process was done in between 13.15 hrs to 13.55 hrs.

I therefore pray that a specific case may kindly be start against arrested accused (1) Dalu Banerjee (53 Yrs) S/O Lt. Ramdas Banerjee of Vill+PO-Bagda, PS-Puncha, Dist-Purulia and the owner of the Shop namely (2) Bittu Singh @ Surjit Singh S/O Gurbachan Singh of Vill-lower Beniasol, SBI Para, PS-Adra, Dist-Purulia under proper section of law.
