

Respected Sir,

In producing herewith one arrested accused person namely Kumeswar Kora (36 Yrs) S/O Lt. Rabi Kora of Vill-Korapara, Moira Colliery Andal, PS-Andal, Dist-Paschim Bardhaman along with seized vehicle (Dumper) bearing Reg. No- WB23F/4399 with loaded sand approx 1300 Cft under proper seizure list. I beg to submit that today (09/04/2023) I ASI Samir Kumar Mishar along with (1) C/2907 Sukumar Dutta (2) C/-245 Rabin Rajak both of Adra P.S were performing evening mobile duty vide Adra PS CC No-1081/23 Date-09/04/2023. During my evening mobile duty at 19.35 hrs I along with force reached at Kali More under Adra PS and at 19.45 hrs found that a vehicle (Dumper) having Regd. No- WB23F/4399 loaded with sand was coming from Raghunathpur side. Accordingly we stopped the said vehicle (Dumper) to search the goods as well as the relevant documents of the goods and the vehicle, but seeing the Police party at Kali more, the driver of the said vehicle was trying to flee away. But we could be able to detain the driver of said vehicle (Dumper). I asked the driver to produce valid documents in respect of said loaded sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admitted his guilt. The driver also failed to produce any paper in respect of the said vehicle. I asked local people who gathered at that place to become witnesses but none came forwarded and all of them left the place. Hence, I seized the vehicle (Dumper) bearing Regd. No- WB23F/4399 loaded with sand approx 1300 Cft in between 20.25 hrs and 20.45 hrs under proper seizure list then I arrested Kumeswar Kora (36 Yrs) S/O Lt. Rabi Kora of Vill-Korapara, Moira Colliery Andal, PS-Andal, Dist-Paschim Bardhaman. I brought the arrested accused person to Adra P.S. and arrange to bring the said seized vehicle (Dumper) loaded with sand. As there is every reason to believe that the driver and owner of the said vehicle (Dumper) with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted vehicle (Dumper) and arrange for its investigation.
