Sir,

In producing herewith one arrested accused persons namely Year Mahammad Ansary (32 Yrs) S/O- Jan Mahammad Ansary of Vill-Haridih, PS-Kashipur, Dist- Purulia (Driver of vehicle No- WB37B/6061 along with one seized Truck (06 Wheeler) bearing registration No- WB37B/6061 loaded with stone of 20 Ton (Approx) out of them 01 kg seized as sample and original driving License of driver namely Year Mahammad Ansary vide D/L No-WB 55 2013 0001527.

I do hereby lodge a complaint to the effect that on 16.04.2023 I, ASI Tanmoy Chatterjee, along with C/1119 Susanta Kr. Sinha and NVF969 Pralay Mahato all are of Adra PS were engaged in Evening Mobile duty vide Adra PS CC No- 1082/23 Dt. 16.04.23. In course of Evening Mobile duty, at about 20:55 hrs I received credible source information that one truck bearing registration No- WB37B/6061 loaded with stone was coming from Raghunathpur side procuring illegally and trying to transport the same to Kashipur side through Adra – Kashipur road in clandestine manner. I immediately intimated you over phone and acquainted you about the information and you directed me to work out the information. In the mean time at about 21:05 hrs I along with force arrived at near Adra Bus stand and found that the above noted vehicle was coming from Raghunathpur side. We indicated the vehicle to stop on Adra-Kashipur pitch road near Adra Bus Stand and on checking it was found that the vehicle was matched given by source and found that approx 20 ton of Stone is loaded inside of the vehicle. Then I requested the driver to produce relevant documents/Challan/cash memo in respect of loaded stone but he failed to produce any valid documents in support of loaded Stone as well as vehicle. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the vehicle have procured said Stone from different illegal source.

So, it is reasonable to believe that the above noted accused driver, registered owner of the said vehicle have obtained the Stone either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same stone in a clandestine manner to Kashipur side knowing it to be stolen, as per their regular practice.

Accordingly, I seized the truck (06 Wheeler) bearing registration No- WB37B/6061 loaded with approx 20 ton of Stone and original Driving License of said driver namely Year Mahammad Ansary, vide D/L No- WB 55 2013 0001527 under proper seizure list duly signed by available witnesses and then I arrested the driver namely Year Mahammad Ansary (32 Yrs), S/O- Jan Mahammad Ansary of Vill-Haridih, PS-Kashipur, Dist-Purulia (Driver of vehicle No- WB37B/6061) in this case. In course of arrest I notified him the ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded Truck.

Under the above circumstances a specific case may kindly be started against (1) Year Mahammad Ansary (32 Yrs) S/O- Jan Mahammad Ansary of Vill-Haridih, PS-Kashipur, Dist- Purulia (Driver of vehicle No-WB37B/6061) (2) Registered owner of vehicle having Reg No-WB37B/6061under proper sections of law.
