Sir,

In producing here with one arrested accused namely Mukesh Barma (45 Yrs) S/O Lt. Om Prakash Barma of Vill - Panchudanga, P.S. - Adra , Dist - Purulia, A/P - Vill-Chhaigada near Mahila Samity, PS- Adra , Dist - Purulia along with following seized articles with seizure list and Memo of Arrest:

1) 20 (Twenty) bottles DIL KHUSH country spirit, 600 Ml. each Rs/-55 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.

I SI Satrugna Mahato of Adra PS do here by lodged a complaint against accused namely Mukesh Barma (45 Yrs) S/O Lt. Om Prakash Barma of Vill - Panchudanga, P.S. - Adra , Dist - Purulia, A/P - Vill-Chhaigada near Mahila Samity, PS- Adra , Dist - Purulia to the effect that on 28/04/2023 at about 18:05 hrs I received a information from a reliable source that one Mukesh Barma has been stock of country spirit illegally in a Jhupri at Mama More Adra. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS CC No-1198/23 dtd.28.04.2023. I reached at Mama More Adra at about 18:25 hrs and hold raid in the Jhupri at Mama More Adra of said Mukesh Barma and found that the said person selling liquor and after seeing the Police party some person fled away and said Mukesh Barma has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Mukesh Barma selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 18.35 hrs to 19.25 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Mukesh Barma (45 Yrs) S/O Lt. Om Prakash Barma of Vill - Panchudanga, P.S. - Adra , Dist - Purulia, A/P - Vill-Chhaigada near Mahila Samity, PS- Adra , Dist - Purulia under proper section of law.
