Sub: To lodge FIR against 1. Owner of tractor bearing registration no- WB55B/4661 and driver of said tractor namely Swapan Murmu (26 yrs) S/O Lt Moti Murmu of vill- Dhadkidih, PS- Arsha, Dist- Purulia and 2. Owner of one blue colour SONALIKA- DI-35 tractor without number plate, having Engine No. 3100FLU14D1047046F18, Chassis No. GZJSR1052862S3 and driver of said tractor namely Nimai Mahato (27y) S/O-Brihashpati Mahato of vill-Sodpuara, PS-Arsha, Dist- Purulia along with trolley loaded with sand (approx 60 CFT) of each trolley.

Sir,

In producing herewith, (1) one tractor bearing registration no- WB55B/4661 and (2) one blue colour SONALIKA- DI-35 tractor without number plate, having Engine No. 3100FLU14D1047046F18, Chassis No. GZJSR1052862S3 along with trolley loaded with sand (approx 60 CFT) of each trolley. Today on 12.04.2023 at about 16.05 hrs acting on source information, I ASI Tapan Kr. Mahata of Arsha PS along with (i) C/238 Dipak Bagti and (ii) C/146 Maheswar Singh Sardar both of Arsha PS, Dist-Purulia, left for PS area vide C.C No. 953/23 Dtd. 12.04.2023. After we reached at Hensla Ghat under Arsha PS at 16.55 hrs, we conducted raid on the Bank of River Bandu under Arsha PS and found that 02 (two) tractors along with trolley loaded with sand was present at Hensla Ghat on the Bank of River Bandu. Seeing the Police party the drivers of the above noted tractors namely (1) Swapan Murmu (26 yrs) S/O Lt Moti Murmu of vill- Dhadkidih, PS- Arsha, Dist- Purulia and (2) Nimai Mahato (27y) S/O-Brihashpati Mahato of vill-Sodpuara, PS-Arsha, Dist-Purulia tried to flee away, but we apprehended them. I asked them to produce valid documents in support of carrying sand, but they could not produce any valid documents. Hence I seized the above noted tractors along with trolleys loaded with sand (approx 60 cft) of each trolley and arrested the drivers namely (1) Swapan Murmu (26 yrs) S/O Lt Moti Murmu of vill- Dhadkidih, PS- Arsha, Dist- Purulia and (2) Nimai Mahato (27y) S/O-Brihashpati Mahato of vill-Sodpuara, PS-Arsha, Dist-Purulia after issuing memo of arrest and brought the said tractors along with trolleys loaded with sand (approx 60 cft) of each trolley and the drivers to Arsha P.S. As there is every reason to believe that the driver and owner of the said tractors with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the 1. Owner of tractor bearing registration no- WB55B/4661 and driver of said tractor namely Swapan Murmu (26 yrs) S/O Lt Moti Murmu of vill- Dhadkidih, PS- Arsha, Dist- Purulia and 2. Owner of one blue colour SONALIKA- DI-35 tractor without number plate, having Engine No. 3100FLU14D1047046F18, Chassis No. GZJSR1052862S3 and driver of said tractor namely Nimai Mahato (27y) S/O-Brihashpati Mahato of vill-Sodpuara, PS-Arsha, Dist-Purulia along with trolley loaded with sand (approx 60 CFT) of each trolley for investigation.
