Sub: To lodge FIR against 1. owner and 2. driver of tractor namely Laxman Gorai (47 yrs) S/O Lt. Kalachand Gorai of vill- Kadampur, PS- Arsha, Dist- Purulia of one Blue colour Powertrac (439 Plus) tractor having Reg. No. WB55B/3095 along with trolley loaded with sand (approx 60 CFT).

Sir,

In producing herewith, 01(one) Blue colour Powertrac (439 Plus) tractor having Reg. No. WB55B/3095 along with trolley loaded with sand (approx 60 CFT) and arrested driver of said tractor namely Laxman Gorai (47 yrs) S/O Lt. Kalachand Gorai of vill- Kadampur, PS- Arsha, Dist- Purulia. Today on 26.04.23 at about 14.15 hrs. acting on source information, I SI Uttam Kr. Mandal of Arsha PS along with (i) C/-1140 Dayamay Mahato and (ii) C/238 Dipak Bagti both of Arsha PS, Dist- Purulia, left for PS area vide C.C No. 1082 Dtd. 26.04.2023. After we reached at Bhurbhuria Ghat, under Arsha PS at 14.45 hrs, we conducted raid on the Bank of Bandu River under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Bhurbhuria Ghat on the Bank of Bandu River. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party those persons and the driver namely Laxman Gorai (47 yrs) S/O Lt. Kalachand Gorai of vill- Kadampur, PS- Arsha, Dist- Purulia of said tractor tried to flee away, but we apprehended the above noted driver. I asked him to produce valid documents in support of carrying sand, but he could not produce as such documents. Hence I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and arrested the driver Laxman Gorai (47 yrs) S/O Lt. Kalachand Gorai of vill- Kadampur, PS- Arsha, Dist- Purulia after issuing memo of arrest and brought the said tractor and the driver to Arsha P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the 1. owner and 2. driver namely Laxman Gorai (47 yrs) S/O Lt. Kalachand Gorai of vill- Kadampur, PS- Arsha, Dist- Purulia of above noted tractor along with the trolley loaded with sand for investigation.
