Sir,

In producing herewith one seized Red Colour Mahindra, Bhoomiputra Tractor, Model B275 DI tractor having Eng No- RMD2EAN2790 & Chasis No- MBNABAEXKMRD06780 along with sand loaded trolley under proper seizure list, I beg to submit that today on (08.04.2023) I along with (1) C/93 Swarup Layek (2) C/1303 Biswanath Majhi both of Baghmundi P.S were performing special mobile duty vide Baghmundi PS CC No-744/2023, Date-08.04.2023. During my special mobile duty at about 22:15 hrs I received a source information that a suspicious tractor loaded with sand was coming from Jilling village side. I informed this matter to O/C Baghmundi PS and after getting necessary permission I along with force left for the said place.

While I along with force arrived at Birgram village road at about 22:15 hrs, found that one tractor was coming from Jilling village side and seeing the Police party the driver of the said tractor fled away leaving the said tractor. Following the driver of the Tractor, myself along with constable namely C/93 Swarup Layek, (leaving the other constable C/1303 Biswanath Majhi near tractor as guard) started chasing the driver. Due to topography of the area and darkness, the driver of the said vehicle somehow managed to escape in a suspicious manner. Due to such suspicious activity of the driver it was ascertained that he with the consent of the owner of the vehicle had been running a clandestine business by illegal means for selling the same to make profit by dishonestly. Hence it is reasoned to belief that the driver of the vehicle procured the said sand from Subarnarekha river bed by fraudulently means or theft by any means for transporting the same to run clandestine business along with the owner of the vehicle. Hence, I seized the tractor vide Eng No-RMD2EAN2790 & Chasis No- MBNABAEXKMRD06780 along with sand loaded trolley in between 22:45 hrs to 22:55 hrs under proper seizure list duly signed by witnesses. I brought the said sand loaded tractor to Baghmundi P.S compound as such there is every reason to believe that the driver and owner of the vehicle with ill motive dealing with sand illegally without any valid document.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation.
