Sir,

In producing herewith the arrested tractor driver namely Samir Lohar (27 Yrs), S/O-Manohar Lohar of Vill-Rella, PS- Baghmundi, Dist-Purulia and one seized Red Colour Mahindra Tractor, B275 DI having Eng No- RFNB02821 & Chasis No- RFNB02821 and bearing Reg No-WB55A/2067 along with sand loaded trolley under proper seizure list, I beg to submit that today on (14.04.2023) I along with (1) C/229 Asit Molla (2) C/1355 Rajib Banerjee, (3) C/2917 Akash Dhibar all of Suisa OP under Baghmundi P.S were performing night mobile duty vide Suisa OP CC No-779/2023, Date-14.04.2023. During night mobile duty at about 03:15 hrs I received a source information that a suspicious tractor loaded with sand was coming from Simali-Parshidih PCC Road near Parsidih jungle. I informed this matter to IC Suisa OP as well as O/C Baghmundi PS and after getting necessary permission I along with force left for the said place.

During my night mobile duty at about 03:45 hrs I along with force reached near Simali-Parshidih PCC Road near Parsidih jungle and found that a Red Colour Mahindra Tractor, B275 DI tractor having Eng No- RFNB02821 & Chasis No- RFNB02821 and bearing Reg No-WB55A/2067 along with trolley loaded with sand was coming from Simali-Parshidih PCC Road near Parsidih jungle. On seeing the Police party near Simali-Parshidih PCC Road near Parsidih jungle, the driver of the said tractor was trying to flee away. But after a hot chase, I could able to detain the driver of the said tractor. I asked the driver Samir Lohar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admitted that he is dealing with illegal sand lifting from Subarna-Rekha river bed. The owner of the said tractor was also involved in this illegal lifting and transportation. Hence, I seized the Red Colour Mahindra Tractor, B275 DI tractor having Eng No- RFNB02821 & Chasis No- RFNB02821 and bearing Reg No-WB55A/2067 along with trolley loaded with sand and 01 KG (Approx) sand from said trolley as sample in between 04:05 hrs to 04:25 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested Samir Lohar (27 Yrs), S/O-Manohar Lohar of Vill-Rella, PS- Baghmundi, Dist-Purulia at 04:30 hrs. I brought the said sand loaded tractor to Baghmundi P.S compound as such there is every reason to believe that the driver and owner of the vehicle with ill motive dealing with sand illegally without any valid document. I also seized the driving license of the said tractor driver under proper seizure list duly signed by the witnesses.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation.
