I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Uttam Machhuar, S/O- Sri Rabin Machhuar of Village Tunturi, P.O.- Suisa, PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 19/04/2023 at about 11:30 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Anup Mondal, JE (Gr-I)(E), Bagmundi CCC 2. Sri Indrajit Bauri, TSH, Bagmundi CCC, entered the premises of Sri Uttam Machhuar, S/O- Sri Rabin Machhuar of Village Tunturi, P.O.- Suisa, PS- Bagmundi, Dist- Purulia and found Sri Uttam Machhuar was enjoying electricity unauthorisedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.07 KVA. As Sri Uttam Machhuar S/O- Sri Rabin Machhuar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Anup Mondal, JE (Gr-I)(E), Bagmundi CCC 2. Sri Indrajit Bauri, TSH, Bagmundi CCC,. The inspection team left the premises at 11:40 a.m. on dated 19/04/2023.
