I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Michel Tushar Amrit, S/O- Late Obed Amrit of Village Pattar, P.O.- Koreng, PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 19/04/2023 at about 01:30 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Anup Mondal, JE (Gr-I)(E), Bagmundi CCC 2. Sri Indrajit Bauri, TSH, Bagmundi CCC, entered the premises of Michel Tushar Amrit, S/O- Sri Late Obed Amrit of Village Pattar, P.O.- Koreng, PS- Bagmundi, Dist- Purulia and found Michel Tushar Amrit was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.70 KVA. As Michel Tushar Amrit S/O- Late Obed Amrit committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Anup Mondal, JE (Gr-I)(E), Bagmundi CCC 2. Sri Indrajit Bauri, TSH, Bagmundi CCC,. The inspection team left the premises at 01:45 p.m.
