

An application under section 156(3) Cr. P.C praying for issuance of a direction upon O.C, Baghmundih P.S for causing investigation

The complainant above named most respectfully beg to state as follows:-


That the complainant is Christian by religion and the accused No.1 is Hindu by religion and she got acquainted with the accused No.1 in the year 2015 when accused No.1 was posted at Adra P.S as N.V.F and during that period a love affairs developed in between them and accused No.1 forcefully compelled the complainant to change her religion from Christian to Hindu.

That thereafter the complainant and the accused No.1 both entered into marital tie and their marriage was solemnised on 22.06.2015 in a Kali Mandir at Belguma Police Line near Bhatbandh, Purulia as per Hindu rites and customs where friends, relatives and other witnesses were present and after marriage both the complainant and the accused No.1 resided together as husband and wife and their marriage has been duly consummated.

That as the complaint is Christian by religion her in law family members did not accept their relation and for that reason she had to stay in a rented house at Chandmaridanga, near Belguma Police Line, Purulia with her husband.

That the accused No.2 happens to be the father, the accused No.3 happens to be the mother and the accused No.4 happens to be the grand mother of the accused No.1.

That it may be mentioned here that due to consumption of marriage the complainant gave birth to a female child namely Dipsikha Mukhejee who is presently aged abut 6 years.



That as the complainant is Christian by religion and the accused persons are Hindu by caste and for that reason her in law family members did not accept the complainant and the mother in law, grandmother in law both openly taunted the complainant by saying that had they given marriage of Prakash elsewhere then they would have fetched more dowry and being a newly wedded wife the complainant had to swallow all such humiliations as she had no other alternative.

That during her stay at her matrimonial home the complainant had to work from dawn to dusk as maid servant and even she was compelled to do all odd household jobs and her mother in law and grandmother in law throughout the day ordered her like master and servant. However, without raising any voice the complainant performed all her matrimonial duties and digested all humiliations in high hope that one day good sense would prevail upon her in laws but day by day they became embolden and even she was not provided with food and drinks with properly and even her husband used to abuse her and assault her at the instigation of her mother in law and grandmother in law on some false and frivolous allegations made by the mother in law and grandmother in law.

That husband of the complainant developed an illicit relationship with one lady and when she protested, her husband used to assault her mercilessly and her mother in law and grandmother in law took the side of her husband saying that male persons has to go out of house for their work so a relationship may develop and there is nothing wrong in it. They also supported him saying many thing may happen outside and females should have to accept many things.

That as the complainant was brought up in an orthodox family, she started hoping against hopes, hoping that one day her husband and in laws would realise their fault and would mend themselves but they did not mend themselves and physical assault and mental abuse upon her went on unabated.

That the mother in law and grandmother in law used to pressurize the complainant to bring a sum of Rs. Two lakes cash from her father's house but as she could not satisfy their demand off and on her husband and in laws family members teased her by calling daughter of beggar.

That on 22.01.2023 the complainant had been to her matrimonial house at Village-Madla, P.S-Bagmundih, District-Purulia, her husband, mother in law, father in law, grandmother in law came there and openly gave out that she does not have right to visit her matrimonial house and all of them started abusing her and started assaulting her at random causing bleeding injury. Thereafter her mother in law

Bulu Mukherjee caught hold of her hair and assaulted her. Her grandmother also abused her by saying "Bejat, Kujat, Daini" and assaulted her with broom. Thereafter to save herself from the assault of her mother in law and grandmother in law she entered into the room of her husband, then her husband also slapped her and assaulted her by fists and blows. Again to save herself she came to her father in law Samir Mukherjee then he also abused her with filthy language and thereafter caught hold of her hair and drove her from their house and snatched her only daughter Dipshikha and somehow she was saved from their clutches.

OF CHIEF JUDIC

To have

That for such assault the complainant sustained injury on her face, neck, back, hands and feet. That apart the complainant also sustained bleeding injury on her nose and for such assault upon her she was medically treated at hospital.

That for torture upon the complainant had lodged complaint with O.C, Bagmundih but till date no specific action has been taken against her husband and in laws.

That the complainant informed the matter to Superintendent of Police, Purulia but till date no case has been started regarding the aforesaid incident.

That the accused persons have committed offence punishable under section 498A/323/506/509/34 IPC and issue process against the accused persons to face trial in the open court of law and do justice thereby.

That a through investigation is required by a specialized agency for unearthing the truth otherwise truth would not see the light of the day.

Under the aforesaid circumstances, It is prayed that your honour may be pleased to send the petition of complaint to O.C, Bagmundih Police Station under section 156 (3) Cr.P.C with a direction to cause investigation into the matter after treating the petition of complaint as FIR and do justice thereby.
