Sub: Complaint Sir,

In producing here with 01 (One) Tractor having Reg. No WB55A-7919 attached with trolley loaded with sand about 100 Cft. (Approx) with proper seizure list.

I beg to state that on 05.04.2023 myself along with force C/1494Manas Mukharjee & C/3218 Sukchand Mandi all of Barabazar PS were performing evening mobile duty Vide C.C. No 984/2023 Dtd. 05.04.2023 and GDE No 268 Dt. 05.04.2023 with Govt vehicle. During my mobile duty received source information regarding loading and sending illegal sand from the side of Bhagabandh village area. Convey the same to you and as per your direction I along with force proceeded to Bhagabandh village area and reached at Bhalaidih Village Morh at about 20:55 hrs and found one tractor attached with trolley coming towards Bhalaidih Morhfrom Routora-Bhagaband Road and seen the Police party the driver fled away after keeping the tractor beside the road near Bhalaidih Morh under Barabazar PS, chased him but somehow the driver managed to escape under the cover of darkness. Myself along with force found that the Tractor was loaded with sand about 100 Cft. Myself along with force waiting for some time but none turned up before me. There is every reason to believe that the owner and driver fraudulently obtained the sand by illegal means to make profit by illegal manners with a clandestine business. Hence, I seized the tractor attached with trolley loaded with sand about 100 Cft. under proper seizure list duty signed by the witnesses at 21:15 hrs.

I held an enquiry about the matter and so far information collected it is crystal clear that the driver and the owner of the vehicle collected the sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mines & minerals. As such there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. order of not extracting sand from the river. As such they were doing illegal business activities.

Under the above facts and circumstance, I pray before you that kindly take

Meedful action against the driver and owner of said tractor.
