Sub: Complaint Sir,

In producing 01 (one) arrested accused driver namely Dukhu Sing (28 yrs) S/o Lakhindar Sing of Vill-Sikri, PS-Chandil, Dist-Saraikalla, Jkd along with one sand loaded (approx 450 Cft.) dumper having Reg. No JH05AW-5324 with proper seizure list and arrest Memo and Inspection Memo.

I beg to state that on today i.e. 13.04.2023 myself along with force C/1182 Santosh Kr. Mahato & C/897 Umapada Dhalla all of Barabazar PS were performing day mobile duty Vide C.C. No 1687/2023 Dtd. 13.04.2023 and GDE No 717 Dt. 13.04.2023 with Govt vehicle. During my mobile duty received source information regarding loading and sending illegal sand from the side of Laldih village area. Convey the same to you and as per your direction I along with force proceeded to Laldih village and reached at Laldi Morh at about 15:05 hrs and found one Dumper coming towards Laldih Morh from Laldih-Berada village Road and detain the vehicle as well as driver of the said sand loaded Dumper and asked him to produce any valid document for transporting the sand but he did not produce any valid documents. During interrogation the driver disclosed his identity as noted above and also stated that he along with his owner of the vehicle collected the sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mines & minerals. As such there is every reason to believe that the driver and owner of the said vehicle with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. order of not extracting sand from the river. As such they were doing illegal business activities. After that I arrested the accused driver namely Dukhu Sing (28 yrs) S/o Lakhindar Sing of Vill-Sikri, PS-Chandil, Dist-Saraikalla, Jkd maintaining all legal formalities regarding arrest and also seized the Dumper having Reg. No JH05AW-5324 loaded with sand approx 450 Cft. under proper seizure list duly signed by the accused driver and witness.

Under the above facts and circumstance, I pray before you that kindly take needful action against the arrested accused driver and owner of said vehicle.
