Sir,

In producing here with one arrested accused driver namely Haradhan Mahato (42 yrs) S/o Lt. Krishnakishor Mahato of Vill-Garasagma, PO-R. Bhagabandh PS-Barabazar, Dist-Purulia along with one tractor bearing regd. No WB55B0352 attached with trolley loaded with sand approx 100 Cft. with proper seizure list and proper memo of arrest.

I beg to state that today on 23.04.2023 myself along with force C/897 Umapada Dhalla & C/3218 Sukchand Mandi all of Barabazar PS performing Evening mobile duty Vide C.C. No 1825/2023 Dtd. 23.04.2023 and GDE No 1320 Dt. 23.04.2023 with Govt vehicle. During my mobile duty received source information regarding loading and transporting of illegal sand from the side of Raigara village area. Convey the same to my I/C and as per direction I along with force proceed to Raigara village area and reached near Raigara Morh at about 20.15 hrs and then at about 20.45 hrs found one tractor attached with trolley coming towards Raigara Morh via village road and seeing the Police party the driver tried to flee away after keeping the tractor near Raigara Morh. I along with my accompanied force somehow apprehended the driver, I asked his identity, he disclosed his identity as Haradhan Mahato (42 yrs) S/o Lt. Krishnakishor Mahato of Vill-Garasagma, PO-R. Bhagabandh PS-Barabazar, Dist-Purulia. On demanding to produce valid documents regarding lifting & transporting the sand but he failed. During interrogation he stated that he along with his owner of the vehicle collected the sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of mines & minerals. As such there is every reason to believe that the driver and owner of the said vehicle with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. order of not extracting sand from the river. As such they were doing illegal business activities. After that I seized the Tractor having Reg. No WB55B0352 attached with trolley loaded with sand approx 100 Cft. under proper seizure list duly signed by the accused driver and witnesses and also arrested the accused driver namely Haradhan Mahato (42 yrs) S/o Lt. Krishnakishor Mahato of Vill-Garasagma, PO-R. Bhagabandh PS-Barabazar, Dist-Purulia after maintaining all legal formalities regarding arrest. Informed him regarding ground of arrest.

Under the above facts and circumstance, I pray before you that kindly take needful action against the arrested accused driver and owner of said vehicle.
