Sir,

In producing here with one arrested accused namely Sushil Tudu (42 Yrs) S/o- Prankrishna Majhi @ Tudu of Village- Rajdlh, P.O- Bamundiha PS- Barabazar, Dist- Purulla and seized articles one white colour Plastic Jerican containing approx 09 (Nine) Ltrs of I.D liquor, on which 500 ml seized as sample under proper seizure list.

I, ASI Dipak Das of Barabazar PS do here by lodge this complaint against Sushil Tudu (42 Yrs) S/o- Prankrishna Majhi @ Tudu of Village- Rajdlh, P.O- Bamundiha PS- Barabazar, Dist- Purulla that on 24.04.2023 during my mobile duty received a source information that one person unauthorized keeping & selling I.D liquor in his house at Rajdlh village under Barabazar PS. I have been then verified the credibility of that information and immediately informed to my I.C. As per direction of I.C Barabazar PS myself along with force had been to Rajdlh village in the house of the alleged person to work out the information. Seeing the Police party, customers fled away. Somehow we apprehended one. On being asked he disclosed his identity as above and confessed that he keeping & selling ID liquors with out any valid documents with intent to make own profit. On searching we found one white colour plastic jarican containing approx 09 (Nine) Ltrs. ID Liquor from his house. Accordingly, I seized the same under proper seizure list duly signed by the said alleged person & witnesses then I take 500 ml from mother contraband as sample and put label on both seized article. Thereafter, I arrest the accused person namely Sushil Tudu (42 Yrs) S/o- Prankrishna Majhi @ Tudu of Village- Rajdlh, P.O- Bamundiha PS- Barabazar, Dist- Purulla after preparing Memo of Arrest & after observing all formalities regarding arrest as per Cr.PC and NHRC guide line. Informed him and his relatives regarding the ground of arrest. The arrest was made at 19.25 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered as per law against said Sushil Tudu (42 Yrs) S/o- Prankrishna Majhi @ Tudu of Village- Rajdlh, P.O- Bamundiha PS- Barabazar, Dist- Purulla and also arrange for its investigation.
