Sir,

In producing here with 01(one) arrested accused person namely Bankim Mahato (23) S/O- Trilochan Mahato of Vill- Agharpur, PO- Ramamoti, PS- Joypur, Dist- Purulia, Driver of vehicle No- WB 55A/8210 along with seized articles i.e. 02 (two) vehicles having registration Nos (1)WB 55A/8210 loaded with approx 24 MTs Coal (2) JH 10 BT/6060 loaded with approx 24 MTs Coal, seems to be steam Coal to the effect that today on 06.04.2023 I ASI Bipin Ch. Mahato along with C/711 Durgapada Barik, HG/1441 Sukumar Kalindi and others all are of Hura P.S were engaged in Naka checking duty on NH60A (Purulia-Bankura road) near at Niyasiya border vide Hura P.S CC No 991/23 Dtd 06.04.2023 and GDE No- 283 Dtd- 06.04.2023 and at about 15.15 hrs we found that Two(02)vehicles registration No- WB 55A/8210 and JH 10BT/6060 loaded with coal were coming from Purulia side towards Bankura. When we intercepted the said vehicles, the driver of vehicle bearing Reg. No- JH 10 BT/6060 fled away. But we managed to apprehend the driver of vehicle bearing Reg. No- WB 55A/8210 and asked to produce valid document in respect of loaded coal but he failed to supply any valid/legal documents in respect of loaded coal and failed to give any satisfactory reason. The matter intimated to O/C Hura. As such there is every reason to believe that the driver, owners of the said trucks and others with ill motive was transporting the coal illegally without any valid document in support of carrying coal. So, they committed offence punishable U/S- 379/411/414/120B IPC & 30(2) CMN Act. Hence I seized the both Two(02) Trucks loaded with coal (Details are mentioned in the attached seizure list) under proper seizure list in presence of police witnesses duly signed by them and also taken sample of 05 kg from the each truck and arrested the above noted one(01) accused driver after observing all formalities regarding arrest and brought the said Trucks loaded with coal and arrested driver to Hura P.S and both the vehicles kept at PS compound.

Therefore, I pray that a specific case may kindly be registered against above noted arrested driver namely (1) Bankim Mahato (23) S/O- Trilochan Mahato of Vill- Agharpur, PO- Ramamoti, PS- Joypur, Dist- Purulia, Driver of vehicle No- WB 55A/8210, owner of the seized vehicles and others U/S- 379/411/414/120B IPC & 30(2) CMN Act. and arrange its investigation.
