Sir,

In producing here with O2(two) arrested accused persons namely Sushil Thakur (32 yrs.) S/O-Ram Bahadur Thakur of Vill- Baroni, PS- Phulwaria, Dist- Bengusarai, State- Bihar, Driver of vehicle No- JH 02 AZ/5849 & Nitish Kumar (25 yrs.) S/O- Brijnandan Ram of Vill- Dumarkol, PS- Rajauli, Dist- Nawada, State- Bihar along with seized vehicles having registration No- JH 02 AZ/5849 loaded with approx 29 MTs Coal, seems to be steam Coal to the effect that on 22.04.2023 I SI Jayanta Chakraborty along with C/330 Banamali Soren, C/346 Shaktipada Rajak and C/631 Tulshidas Satpati all are of Hura P.S were engaged in night mobile duty on NH60A (Purulia-Bankura road) vide Hura P.S CC No 1186/23 Dtd 22.04.2023 and GDE No- 1073 Dtd- 22.04.2023 and on 23.04.2023 at about 08.05 hrs when we were performing NAKA checking duty at Parther sathi motel in course of night mobile duty, intercepted one (01) vehicle registration No- JH 02 AZ/5849 was coming from Purulia side towards Bankura and asked the driver about the loaded materials. He replied that he was carrying FORTUNE oil but after checking we found that he was actually carrying coal. Accordingly he was asked to produce valid document in respect of loaded coal and he produced Transport Challan, Tax invoice and others documents (Details are mentioned in the attached seizure list) where it is clearly mentioned that the coal was transported from Konar Expansion OCP to Bangali Tola Ramgarh. But the driver was going to Bankura district, West Bengal to unload the loaded coal in the said truck without any valid documents of transportation to that place. The matter intimated to O/C Hura PS. As such there is every reason to believe that the driver and others transporting the coal illegally in the place other than the destination mentioned in the challan with ill motive. So, they committed offence punishable U/S- 379/411/414/120B IPC. Hence I seized one (01) Truck loaded with coal (Details are mentioned in the attached seizure list) under proper seizure list in presence of police witnesses duly signed by them and also taken sample of O3 kg from the truck and arrested the above noted two(O2) accused persons after observing all formalities regarding arrest and brought the said Truck loaded with coal and arrested accused persons to Hura P.S and the vehicle kept at PS compound.

Therefore, I pray that a specific case may kindly be registered against above noted arrested accused persons namely Sushil Thakur (32 yrs.) S/O- Ram Bahadur Thakur of Vill- Baroni, PS-Phulwaria, Dist- Bengusarai, State- Bihar, Driver of vehicle No- JH 02 AZ/5849 & Nitish Kumar (25 yrs.) S/O- Brijnandan Ram of Vill- Dumarkol, PS- Rajauli, Dist- Nawada, State- Bihar, owner of the seized vehicle and others U/S- 379/411/414/120B IPC and arrange its investigation.
