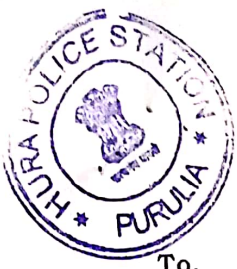



Sir,

In producing here with 02(two) arrested accused person namely 1) Jyoti Poddar(27 yrs.) S/O- Rupnarayan Poddar of Vill- Naiyadiah, PS- Narayanpur, Dist- Jamtara, Jharkhand, Driver of vehicle No- WB 55A/6660 & 2) Dulal Chandra Mandal(27 yrs.) S/O- Kirtan Mandal of Vill- Ghati Shimla, PS- Narayanpur, Dist- Jamtara, Jharkhand, Driver of vehicle No- WB 55A/6673 along with seized articles i.e. 02 (two) vehicles having registration Nos (1)WB 55A/6660 loaded with approx 24 MTs Coal (2) WB 55A/6673 loaded with approx 24 MTs Coal, seems to be steam Coal to the effect that today on 27.04.2023 I ASI Subhendu Mahato along with C/1429 Jagadish Ch. Mahato, NVF/68 Mahanta Mahato and others all are of Hura P.S were engaged in Naka checking duty on NH60A (Purulia-Bankura road) near at Ladhurka Reliance petrol pump vide Hura P.S CC No 1245/23 Dtd 27.04.2023 and GDE No- 1303 Dtd- 27.04.2023 and at about 15.25 hrs we found that Two(02)vehicles registration No- WB 55A/6660 and WB 55A/6673 loaded with coal were coming from Purulia side towards Bankura. We managed to stop the said vehicles and asked the drivers to produce valid documents in respect of loaded coal but they failed to supply any valid/legal documents in respect of loaded coal and failed to give any satisfactory reason. The matter intimated to O/C Hura. As such there is every reason to believe that the driver's, owners of the said trucks and others with ill motive was transporting the coal illegally without any valid documents in support of carrying coal. So, they committed offence punishable U/S- 379/411/414/120B IPC & 30(2) CMN Act. Hence I seized the both Two(02) Trucks loaded with coal (Details are mentioned in the attached seizure list) under proper seizure list in presence of police witnesses duly signed by them and also taken sample of 05 kg from the each truck and arrested the above noted 02(two) accused driver after observing all formalities regarding arrest and brought the said Trucks loaded with coal and arrested driver's to Hura P.S and both the vehicles kept at PS compound. On interrogation the arrested accused persons stated that both the vehicles loaded near at Pipratard under Joypur PS under the supervision of Manjit Singh @ Sardarji @ Singhji of Chas morh.

Therefore, I pray that a specific case may kindly be registered against above noted arrested driver's namely 1) Jyoti Poddar(27 yrs.) S/O- Rupnarayan Poddar of Vill- Naiyadiah, PS- Narayanpur, Dist- Jamtara, Jharkhand, & 2) Dulal Chandra Mandal(27 yrs.) S/O- Kirtan Mandal of Vill- Ghati Shimla, PS- Narayanpur, Dist- Jamtara, Jharkhand, 3) Manjit Singh @ Sardarji @ Singhji of Chas morh, 4) owner of the seized vehicle No- WB 55A/6660, 5) owner of the seized vehicle No- WB 55A/6673 and others U/S- 379/411/414/120B IPC & 30(2) CMN Act. and arrange its investigation.
