
Sir,

In producing here with 01(one) arrested accused person namely Abu Kayam Mondal (35 yrs.) S/O- Barkatullya Mondal of Vill- Ramchandrapur, PS- Baduria, Dist- North 24 Pgs., Driver of vehicle No- WB 23D/1314 along with seized articles i.e. 01 (one) vehicle having registration No- WB 23D/1314 loaded with approx 24 MTs Coal, seems to be steam Coal to the effect that on 27.04.2023 I ASI Amal Kr. Pati along with C/877 Basudeb Mahato, C/1052 Shyamlal Murmu, NVF/680 Bibhas Mandi and others all are of Hura P.S were engaged in Naka checking duty on NH60A (Purulia-Bankura road) near at Ladhurka Reliance petrol pump vide Hura P.S CC No 1251/23 Dtd 27.04.2023 and GDE No- 1341 Dtd- 27.04.2023 and on 28.04.2023 at about 00.05 hrs we found that 01(two)vehicle registration No- WB 23D/1314 loaded with coal were coming from Purulia side towards Bankura. We managed to stop the said vehicle and asked the driver to produce valid documents in respect of loaded coal but he failed to supply any valid/legal documents in respect of loaded coal and failed to give any satisfactory reason. The matter intimated to O/C Hura. As such there is every reason to believe that the driver, owners of the said truck and others with ill motive was transporting the coal illegally without any valid documents in support of carrying coal. So, he committed offence punishable U/S- 379/411/414/120B IPC & 30(2) CMN Act. Hence I seized 01(one) Truck loaded with coal (Details are mentioned in the attached seizure list) under proper seizure list in presence of police witnesses duly signed by them and also taken sample of 05 kg from the truck and arrested the above noted accused driver after observing all formalities regarding arrest and brought the said Truck loaded with coal and arrested driver to Hura P.S and the vehicle kept at PS compound. On interrogation the arrested accused person stated that the vehicle loaded near at Pipratard under Joypur PS under the supervision of Manjit Singh @ Sardarji @ Singhji of Chas morh.

Therefore, I pray that a specific case may kindly be registered against 1) Abu Kayam Mondal (35 yrs.) S/O- Barkatullya Mondal of Vill- Ramchandrapur, PS- Baduria, Dist- North 24 Pgs. Driver of vehicle No- WB 23D/1314, 2) Manjit Singh @ Sardarji @ Singhji of Chas morh, 3) owner of the seized vehicle No- WB 23D/1314 and others U/S- 379/411/414/120B IPC & 30(2) CMN Act. and arrange its investigation.
