In producing here with 02(Two) arrested accused persons namely (i) Pinku Karmakar (20) S/O Rama Karmakar of Vill- Bengo, PS- Jhalda, Dist- Purulia and (ii) Milan Mahato (20) S/O Abiram Mahato of Vill-Chatamghutu, PS- Jhalda, Dist- Purulia and along with (i) One tractor having Registration No WB67-7778, Chassis No-RDT30500 & Engine No-RDT30500 attached with trolley loaded with approx 100 cft. sand (ii) One tractor having Registration No WB55A-6291, Chassis No-MBNABACFCHRD00413 & Engine No-RHD2BBN0993 attached with trolley loaded with approx 100 cft. sand. The fact in brief is that today (11.04.2023) I along with force namely i) C/2696-Subal Mahato ii) C/3403-Lambudhar Singh Mura (iii) C/736 Subrata Hembram (iv) C/318 Nemai Das were performing night mobile duty at Tulin OP area vide Tulin OP GDE No- 327 Dated- 10/04/2023 in consonance with Tulin OP CC No- 1035/23 Dated- 10/04/2023. During my night mobile duty, I received a credible source information that two Tractors was lifting & carrying sand illegally and coming from Bondih Ghat which is situated on Subarnarekha River at Jharkhand Purulia Border & coming towards Tulin. Subsequently, I informed you and as per your order, I placed Naka at Choupad more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the two tractors were proceeding towards Choupad more. Consequently, we intercepted the said Tractors at Naka checking point at about 02:15 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicles (Tractor) started to flee away. After hot chase we managed to apprehend them. On being asked, the driver of the vehicles disclose their name noted in the supra. I asked the driver of the vehicles to produce the valid documents in respect of the vehicles as well as the loaded with sand trolley. But the driver of the said vehicles could not able to produce any kind of documents in respect of the Tractors and the sand loaded trolley. I repeatedly asked the driver to produce the valid papers but they stated differently in different times. The incoherent statement of the drivers purported to be a suspicious to us. It was ascertained that the driver of the tractors loaded the said sand in cahoots with the owner of the vehicles by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasonable to belief that they in cahoots with the owners of the vehicle procured the said sand from Subarnarekha River at Bondih Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle with (i) One tractor having Registration No WB67-7778, Chassis No-RDT30500 & Engine No-RDT30500 attached with trolley loaded with approx 100 cft. sand (ii) One tractor having Registration No WB55A-6291, Chassis No-MBNABACFCHRD00413 & Engine No-RHD2BBN0993 attached with trolley loaded with approx 100 cft. sand under proper seizure list in presence of witnesses duly signed by them and also arrested the driver of the tractors namely (i) Pinku Karmakar (20) S/O Rama Karmakar of Vill- Bengo, PS- Jhalda, Dist- Purulia and (ii) Milan Mahato (20) S/O Abiram Mahato of Vill-Chatamghutu, PS- Jhalda, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against them. Thereafter, I brought the said Tractors to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the driver of the tractors namely (i) Pinku Karmakar (20) S/O Rama Karmakar of Vill- Bengo, PS- Jhalda, Dist- Purulia and (ii) Milan Mahato (20) S/O Abiram Mahato of Vill- Chatamghutu, PS- Jhalda, Dist- Purulia and the Owner of the said tractors as they committed an offence U/S 379/411/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.
