Sir,

In producing here with arrested accused persons namely 1) Niyamat Sk (27) S/O Sk Meraj, 2) Sk Golam Tahu (29) S/O Sk Karim 3) Sk Tohid (28) S/O Sk Forid & 4) Sk Irfan (29) S/O Sk Wahab all of Bagandih, Ward No-07, PS- Jhalda, Dist- Purulia and seized articles (i) One house breaking iron Rod length approx 2.5 ft (ii) One knife attached with plastic handle length approx 1 ft and sharp edge of knife is approx. 08 inches (iii) one lylon rope in red colour length approx 19 mtr iv) One Bambo stick length approx 3.5 ft lodged complain against them and 12/13 others 1) Sk Saddam 2) Bhalka 3) Sk Imroj @ Moja all of Vill- Kantadih, PS- Jhalda, Dist- Purulia were among them and 1) Owner of the bolero pick up van having Reg No JH15P5640 2) Driver of the bolero pick up van having Reg No JH15P5640 to the effect that on 14/04/2023 at about 23.25 Hrs during my night mobile duty received a credible tip that a gang of dacoits being armed with deadly weapons assembled beside a new construction house near Kansra village and they were preparing themselves for committing dacoity at Jhalda Town. Subsequently I, informed to you as well as the Duty Officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 691 Dated 14/04/2023. On getting the tip off as per kind order myself accompanied with force who were detailed for the Night Mobile Duty with me namely (i) C/864-Mahabir Mahato (ii) C/240-Manoranjan Bagti (iii) NVF/826-Ramchandra Mahato (iv) HG/1681-Manmotha Kumar all of Jhalda PS vide CC No. 1125/23 dated 14/04/2023 & vide Jhalda PS GDE NO 685 Dated 14/04/2023 immediately proceeded to the anticipated place of assembly to work out the information and reached near Sikra Mountains & Hill Resorts at 23:45 Hrs leaving the Police vehicle No- WB 56M 7939 and started to proceed for the anticipated place on foot. At 23:55 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 16/17 persons assembled beside a new construction house near Kansra village and 20 mtr away from Jhalda Gola road and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 04 (Tour) of them at 00:05 Hrs while the rest 12/13 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused person (i) One house breaking iron Rod length approx 2.5 ft from the possession of Niyamat Sk, (ii) One knife attached with plastic handle length approx 1 ft and sharp edge of knife is approx. 08 inches from the possession of Sk Golam Tahu (iii) one lylon rope in red colour length approx 19 mtr from the possession of Sk Tohid (iv) One Bambo stick length approx 3.5 ft from the possession of Sk Irfan. Subsequently, I seized in between 00:35 hrs to 01:15 hrs on 15/04/2023 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, (i) One house breaking iron Rod length approx 2.5 ft (ii) One knife attached with plastic handle length approx 1 ft and sharp edge of knife is approx. 08 inches (iii) one lylon rope in red colour length approx 19 mtr iv) One Bambo stick length approx 3.5 ft from the place of assembly under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat. On interrogation they confessed their guilt and they stated that they have assembled there with 12/13 others, 1) Sk Saddam 2) Bhalka 3) Sk Imroj @ Moja all of Vill- Kantadih, PS- Jhalda, Dist- Purulia were among them for committing a house dacoity in a Maru family at Jhalda Town and they also stated that one bolero pick up van having Reg No JH15P5640 Parked along Jhalda Gola road towards Kansra village for their escape. Subsequently, we hot chased that vehicle but in vain and the vehicle entered into Jharkhand part. I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonable to believe that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them.


Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Niyamat Sk (27) S/O Sk Meraj, 2) Sk Golam Tahu (29) S/O Sk Karim 3) Sk Tohid (28) S/O Sk Forid & 4) Sk Irfan (29) S/O Sk Wahab all of Bagandih, Ward No-07, PS- Jhalda, Dist- Purulia along with 12/13 others, 1) Sk Saddam 2) Bhalka 3) Sk Imroj @ Moja all of Vill- Kantadih, PS- Jhalda, Dist- Purulia were among them and 1) Owner of the bolero pick up van having Reg No JH15P5640 2) Driver of the bolero pick up van having Reg No JH15P5640 and others under proper section of law.
