- 2) _____ That, your Complainant is rightfull owner of the land bearing R.S./L.R. Plot No. 1209,1210 of Mouza - Velaidih, which is Bastu Land and she obtain the said land after death of her husband namely Rasaraj Sahis and duly R.S. and L.R. operation has been recorded in the name of Rasaraj Sahis exclusively. The accused persons have got no right, title and possession over said land.
- 3) _____ That, on the date of occurance i.e. on 05/03/2023 all the accused persons beingarmed with deadly weapons like Lathi, Tangi, Kural etc. forming unlawful assembly with an intention to commit murder and also to damage the house of the complainant forcibly and illegally enter into the land bearing R.S./L.R. Plot No.1209,1210 of Mouza - Velaidih and they started to damage the roof of the house of the Complainant by throwing stone and throughout the furniture and damage the boundary wall. All the accused persons abuse in various filthy language and called the complainant as "Dainy, Beti" etc.
