Sir,

In producing herewith one arrested accused person namely Sricharan Kaibartya (34 yrs) S/o-Late Muruli Kaibartya of Joypur Kaibartyapara PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. 14 (fourteen) bottles country spirit "DIL KUSH" strength measuring 600 ML each bottles out of which one bottle taken as sample under proper seizure with label.

I ASI Swapan Mandal of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (08/04/2023) at about 18:55 hrs when myself along with C/-3447 Majnu Ansary, NVF/-1021 Bablu Mahato were performed Special Mobile duty vide Joypur PS C.C. No-565 date-08/04/2023, as per my source information I reached at Joypur Atakol Morh in the Shop of Sricharan Kaibartya under Joypur PS and found that the above noted accused person selling country spirit "DIL KUSH" in the shop. On seeing Police persons, he concealed his presence at that shop, but on searching we able to trace out him and also to found that 14 (fourteen) bottles of country spirit "DIL KHUSH" which was kept conceal in this shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling country spirit to the local people in Joypur Bazar area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such country sprit. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 19:25 hrs to 19:45 hrs & label duly signed by him and other available witness after taking 01 bottle of DIL KUSH as sample out of 14 (fourteen) bottle of DIL KHUSH each bottle 600 ML.

During further interrogation he confessed his guilt as such I arrested him today (08/04/2023) at 19:50 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Sricharan Kaibartya (34 yrs) S/o- Late Muruli Kaibartya of Joypur Kaibartyapara PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
