Respected Sir,

In producing herewith seized 01 (one) Red Colour Tractor bearing Registration No-WB55B-4716 along with trolley loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (12/04/2023) I, LSI Sumana Kar along with force (1) C/-3447 Majnu Ansary (2) NVF/-817 Bhubaneswar Mahato all of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-615/23 Date-12/04/2023. During my mobile duty at about 19:45 hrs received a credible source information that one Tractor loaded with sand is coming from Uparkahan side under Joypur PS, I along with force reached at Narayanpur morh under Joypur PS and found that one Red Colour Tractor bearing Registration No-WB55B-4716 loaded with sand (100 CFT approx). On seeing the Police party at Narayanpur morh under Joypur PS, the driver of the said Tractor fled away leaving the tractor standing beside the village morh. We rushed to the Tractor and searched the said Tractor and also searched surrounding the P.O but I did not trace out the driver / owner of the said Tractor. Hence, I seized the Tractor bearing Registration No- WB55B-4716 along with trolley loaded with sand (100 CFT approx) under proper seizure list in between 20:05 hrs to 20:25 hrs in presence of available witnesses and I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the **driver** and **owner** of the said Tractor is dealing with sand illegally and transporting with ill motive without any valid document.

Hence, they are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the said Tractor may kindly be started and arrange for its investigation.
