Respected Sir,

In producing herewith seized 02 (two) Tractors bearing Registration No (1) JH09AV-4193 (Eicher-380 USJ silver colour) along with trolley (2) Red Colour Mahindra Tractor without Registration number and Chassis No-MBNABAEAKHRG01403 along with trolley each Tractors loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (20/04/2023) I, ASI Tarapada Hazari along with force (1) C/-3447 Majnu Ansary (2) HG/-1717 Phonibhshan Mahato all of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-715/23 Date-20/04/2023. During my mobile duty at about 09:05 hrs received a credible source information that two Tractors loaded with sand is coming from Katabera Ghat, Kongashabati River towards Jharkhand side, I along with force reached at Selani morh under Joypur PS and found that 02 (two) Tractors bearing Registration No (1) JH09AV-4193 (Eicher-380 USJ silver colour) along with trolley (2) Red Colour Mahindra Tractor without Registration number and Chassis No-MBNABAEAKHRG01403 along with trolley each Tractors loaded with sand (100 CFT approx). On seeing the Police party at Selani village morh under Joypur PS, the drivers of the both Tractors fled away leaving they tractors standing beside the village morh. We rushed to the Tractors and searched the both Tractor and also searched surrounding the P.O but I did not trace out the drivers / owners of the said Tractors. Hence, I seized the 02 (Tractors bearing Registration No (1) JH09AV-4193 (Eicher-380 USJ silver colour) along with trolley (2) Red Colour Mahindra Tractor without Registration number and Chassis No-MBNABAEAKHRG01403 along with trolley each Tractors loaded with sand (100 CFT approx) under proper seizure list in between 09:25 hrs to 09:45 hrs in presence of available witnesses and I brought the said Tractors to Joypur P.S. As such there is every reason to believe that the **drivers** and **owners** of the said both Tractors are dealing with sand illegally and transporting with ill motive without any valid document.

Hence, they are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the both Tractors may kindly be started and arrange for its investigation.
