Sir,

In producing herewith one green colour JOHN DEERE tractor bearing Reg. No. WB-55B/5026- attached with Trolley without number plate loaded with sand approx. 100 cft.

The fact of the case in brief is that on 05/04/23 I along with C/1130 Asik Ansari and C/3030 Subhendu Mondal both of Kenda PS were performing night mobile duty. During my night mobile duty on 06/04/23 at about 00:15 hrs. when we reached at near Kuda Hospital Morh found that the above noted tractor was coming from Manbazar side. On seeing the Police party driver of the said vehicle stopped his tractor in a distance and he fled away after keeping the tractor near Kuda Hospital Morh. We chased him but could not apprehend. It is ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So I seized one green colour JOHN DEERE tractor bearing Reg. No. WB-55B/5026- attached with Trolley without number plate loaded with sand approx. 100 cft. under proper seizure list in presence of available witnesses duly signed by them. Thereafter arrange driver from my source and brought the tractor at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the above seized tractor bearing Reg. No. WB-55B/5026 attached with Trolley without number plate loaded with sand approx. 100 cft.
