Sub: Complaint against Akshay Mahato (53 yrs), S/O Raban Mahato of Vill-Parultanr , PS- Arsha, Dist-Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Akshay Mahato (53 yrs), S/O- Raban Mahato of Vill-Parultanr , PS- Arsha, Dist-Purulia with seizure of approx 10 (Ten) liters illicit liquor (Cholai) from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (25.04.2023) during evening mobile duty acting on secret source information, I held raid at 18:35 hrs in the food shop of above noted person which is situated at Rampur more under Kotshila PS, Dist- Purulia who stocked illicit spirit in food shop at Rampur more. I searched the place and found approx 10 (Ten) Liters illicit spirit which was kept in a white colour plastic Jaricane. On interrogation, he disclosed his name and address as noted above and also stated that he sells the same for his gain in lieu of money. On demand he failed to produce any valid documents in respect of illicit spirit which was kept in his food shop. Accordingly I seized the same under proper seizure list in between 18:45 hrs to 18:55 hrs in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 19:05 hrs U/S- 67 B.E. Act and during arrest, the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized illicit liquor 500 (Five Hundred) ml. was taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Akshay Mahato (53 yrs), S/O- Raban Mahato of Vill-Parultanr , PS- Arsha, Dist-Purulia violated the provision of section 18 (i) B.E. Act. for possessing and selling of illicit spirit without obtaining license from a licensing vendor and in contravention, he Committed an offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid C/297 Apurba Pandey & C/1543 Prabir kr Mandal accompanied me Vide Kotshila P.S C.C No 1072/2023, Dated 25.04.2023.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against the arrested accd person namely Akshay Mahato (53 yrs), S/O- Raban Mahato of Vill-Parultanr , PS- Arsha, Dist-Purulia.
