In producing herewith 02(Two) seized Tractor with Trolley loaded with sand (Approx 100 CFT in each trolley) 1. One Tractor with trolley loaded with sand approx 100 Cft Bearing registration No- WB55B/2687, Engine No. NKG@EMJ0110 & Chassis No. MBNABAEXKKJH01957, Red Color Mahindra B 275 DITUMKM DLX 2. One New Tractor with trolley loaded with sand approx 100 Cft without Registration, Engine No. NPK2JAE0011 & Chassis No. MBNTFAJAEPNK02541 (Mahindra 475) Red Color.

The fact of the case in brief is that on 24/25.04.2023, I S.I Prabir Kr Dey along with C/460 Nirmalendu Sinha Mahapatra and C/888 Subhasis Hansda were engaged nigth mobile duty vide Manbazar PS GDE No-911 & CC No. 1057/23 dated - 24.04.2023. During mobile duty on 25.04.2023 at about 03:19 hrs. received credible source information that the above noted Tractors is coming from Bhengardih Ghat side (Kumari river) through Bhengardih village towards Manbazar side loaded with sand without valid paper. After receiving this information we proceeding towards Manpur village side under Manbazar PS. At about 03:45 hrs while we reached near Manpur village found that the above noted Tractors were coming from Bhengardih Ghat side. On seeing the police party the drivers of the said Tractors stopped the Tractors in a distance from Manpur village. We rushed to the Tractors and the drivers then fled away after keeping the Tractors at Manpur village Road side. We searched the said Troctors and found that the Troctors is loaded with sand. I searched for any valid documents in respect of sand loaded in the Tractors as well as the valid documents in respect of that Tractors but nothing found. Accordingly I seized the said Tractors 11. One Tractor with trolley loaded with sand approx 100 Cft Bearing registration No- WB55B/2687, Engine No. NKG@EMJ0110 & Chassis No. MBNABAEXKKJH01957, Red Color Mahindra B 275 DITUMKM DLX 2. One New Tractor with trolley loaded with sand approx 100 Cft without Registration, Engine No. NPK2JAE0011 & MBNTFAJAEPNK02541 (Mahindra 475) Red Color loaded with sand measuring approx 100 CFT in each trolley under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging drivers from my source. I brought the said Tractors to Manbazar PS. As such there is every reason to believe that the drivers and owners of the said Tractors 1. One Tractor with trolley loaded with sand approx 100 Cft Bearing registration No- WB55B/2687, Engine No. NKG@EMJ0110 & Chassis No. MBNABAEXKKJH01957, Red Color Mahindra B 275 DITUMKM DLX 2. One New Tractor with trolley loaded with sand approx 100 Cft without Registration, Engine No. NPK2JAE0011 & Chassis No. MBNTFAJAEPNK02541 (Mahindra 475) Red Color are transporting & lifting sand illegally without any valid documents in support of carrying / Lifting sand and they deal with the business of stolen sand in a clandestine manner since few days. So, they are liable for offence punishable as per law.

Therefore, I pray before you that a specific case against the driver and owner of said Tractors 1. One Tractor with trolley loaded with sand approx 100 Cft Bearing registration No- WB55B/2687, Engine No. NKG@EMJ0110 & Chassis No. MBNABAEXKKJH01957, Red Color Mahindra B 275 DITUMKM DLX 2. One New Tractor with trolley loaded with sand approx 100 Cft without Registration, Engine No. NPK2JAE0011 & Chassis No. MBNTFAJAEPNK02541 (Mahindra 475) Red Color may kindly be started as per law and arrange for its investigation.
