#### Sub: Regarding theft of expensive copper cables fitment items

Respected Sir,

I, Sh Sayan Halder S/o Late Tarapada Halder, Vill: Chatterjeepara, Post: Madanpur. PS: Chakdah, Dist: Nadia, Pin: 741245 at present on behalf of Shree Cement Purulia Plant (A Unit of Shree Cement East Pvt Ltd) at present working as Asst Security Officer, Vill: Digha & Parbatpur, Block: Neturia, Tehsil: Raghunathpur, Dist.: Purulia, Pin: 723121 like to inform the following matter:

That on 22nd Mar 2023 around 12:30 pm during official technical review of the ongoing commissioning work by the electrical dept through the contractor M/s Maharaja, whose project head is Mr. Arvind Kumar (Mob No: 9179528912) within our site premises were around 27 copper cables were found missing from the panel where the cables were already fitted with tie- wrap during initial receipt. The copper cables are internal part to the panel board and are received along with the panel board. Initial search was done but copper cables were not found.

Initial investigation was done by the company end and concerned persons related to the work were called for initial investigation. Statement of all workers including that of service Engineer were heard verbally during initial internal investigation. Still the actual cause and reason of missing items could not be ascertained and after complete search, it is certified that the copper cables have been stolen and it is suspected that the theft is been done by internal staff working around the area where the cable were being used for fitment. The tentative cost of the stolen/missing items is around between Rs.2.5 Lakhs to Rs.3 Lakhs (for 27 copper cables). (pics attached as Annexure IV, V and VI for instant reference please.)

It is suspected that the theft may be done by the workers of M/s Maharaja only though as per statement no one is accepting or agreeing to the fact that it is stolen.
