SUB: COMPLAINT AGAINST THEFT

On behalf of Shree Purulia Cement Plant (Shree Cement East Pvt Ltd), I Lieutenant Colonel Raj Shekhar Neogi(retd), presently employed as Dy GM- Security at Shree Purulia Cement Plant located at Vill: Digha & Parbatpur, PO: Digha, PS: Neturia, states the following;

On 18th Apr 23, at around 12:00 pm near the ICDS, which is co-located along the boundary of our site near the main gate, we intercepted an incident, where a miscreant was found carrying 4 pieces of scaffolding pipes on a cycle and rushing towards village Digha. Self with Sh. Sayan Halder and two security guards who were on patrolling ran after the thief and caught red handed with the stolen items. The details of the miscreant is as below:
