Entered the premises of Prakash Chakraborty (user) S/O - Lt. Anil Chakraborty And inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L i.e. U/S 135 (1) (a) was detected.

From the above arrangement he/she was using the following equipments

- 1) Electric fan = 3 Nos, 80W each = 240W
  - 2) Electric tube light = 2 Nos, 40W each = 80W
  - 3) LED light = 3 Nos, 10W each = 30W
  - 4) T.V. = 1 No, 180W each = 180W
- Total = 530W

The inspection team left the premises after disconnection the hooking Line from pole side by our L.T Mobile at 1:35 p.m. on 25.4.2023

The accused person has committed theft an offence U/S 135 (1)(a) of the Electricity Act - 2003 & subsequently Electricity (Amendment) 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
