Entered the premises of Bikash Chakraborty S/O - Pramalika Nalh - Chakraborty And inspected his/her premises. During inspection theft of electricity was detected i.e he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L i.e U/S 135 (1) (a) was detected.

From the above arrangement he/she was using the following equipments

- 1) Electric Fan - 5 Nos - 80 watt each = 400 watt.
- 2) Tubelight 7 Nos - 40 watt each = 280 watt.
- 3) T.V - 1 No - 180 watt each = 180 watt
- 4) Total = 860 watt.

Out of which I seized the following

- 1) 2x1 core Pvc cable length - 6 ft + (approx)
- 2) with Tapping / By-passing / hooking arrangement.

Seizure list was prepared at the site and accused person refused to sign/signed.

The inspection team left the premises after disconnection the hooking Line from pole side by our L.T Mobile at 1:20 PM on 25.04.23

The accused person has committed theft an offence U/S 135 (1)(a) of the Electricity Act - 2003 & subsequently Electricity (Amendment) 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
